AAP workers protest against Sanjay Singh's arrest by ED

NEW DELHI: Following the arrest of AAP Rajya Sabha MP Sanjay Singh, the party workers and leaders on Tuesday held a protest in the national Capital.

The AAP also claimed that while they were on the way to gherao BJP headquarters, the Delhi Police thrashed party workers and detained hundreds of them. Scores of AAP party workers and leaders also raised slogans "Sanjay Singh sher hai" and "Modi jab-jab darta hai, ED ko aage karta hai." AAP Rajya Sabha MP Sandeep Pathak said during the protest that the BJP had got Sanjay Singh arrested in a bogus case because they know that now it is difficult for the saffron party to stop the AAP.

"The BJP is misusing institutions like the ED and the CBI for its electoral gains. The BJP is conspiring to destroy the Constitution and democracy. I want to tell the BJP government that

ED searches locations linked to Delhi AAP MLA Amanatullah Khan



NEW DELHI: The Enforcement Directorate (ED) on Tuesday carried out searches at several locations linked to Aam Aadmi Party (AAP) MLA Amanatullah Khan in the national capital. An ED source confirmed that the agency sleuths were carrying out the searches in the premises linked to Khan. The source said that the agency's actions were in connection with the Waqf Board case. However, officials remained

tight-lipped on the case. The ED action comes in the wake of the CBI and Delhi government's ACB registering the case in the Waqf board. The ACB had arrested Khan, an AAP MLA from the Okhla Assembly constituency in South Delhi in September last year. The action comes days after the ED arrested party Rajya Sabha MP Sanjay Singh last Wednesday in makeshift temple in Ram connection with the alleged Janmabhoomi.

Rs. 798.44 cr Return and Compensation amount paid to Contractors due to 12 Toll Plazas closed & exemption on 53 plazas

In March 2016 Maharashtra's 12 Toll Plazas closed down and exemption on 53 plazas, the Maharashtra State Road Development Corporation (MSRDC) and the Public Work Development $(PWD)\, Departments\, have\, to\, pay$ Rs. 798.44 crores as compensation & return to the Toll Plaza Contractors, revealed an RTI filed by activist Anil Galgali.

stated that out of the total 38 Plazas managed by the PWD 11 were closed and Rs. 226.51 crores was paid to the contractor as full & Final payment. Whereas out of the 53 plazas maintained by the MSRDC only 1 was closed for which the full & Final payment return amounted to Rs. 168 crores. Out of the 19 projects of the PWD in the 27 toll plazas the Car's, Jeep's, State Transport Buses (ST) and School buses were given exemption. But this amounted to return of Rs. 179.69 crores as compensation for Year 2015 -16. Similarly for MSRDC's 12 projects which consists of 26 Toll Plazas because of the exemption given to the Cars, Jeep, ST & school buses the compensation for Year

GST Council's decisions are a step forward

he recent decisions by the Goods and Services Tax (GST) Council have brought clarity to a number of long-standing tax ambiguities. Notably, the resolution of the tax treatment on corporate and personal guarantees for bank loans and the significant reduction of GST on molasses from 28% to 5% are commendable moves. The latter, in particular, is expected to ease the financial burden on sugar mills, thereby accelerating payments to farmers. However, the Council's decision to abstain from taxing extra neutral alcohol (ENA) used in alcoholic beverages is particularly noteworthy. Given that alcohol for human consumption remains outside the GST purview, taxing ENA would have complicated matters, especially since the tax couldn't be offset against State levies on the final product. The industry's plea for clarity on this matter has finally been addressed, marking an end to years of legal wrangling and inconsistent court rulings. The increased frequency of the Council's meetings this year, compared to the previous year, is a positive sign. Looming large is the Council's upcoming discussion on the future of the GST Compensation Cess and its potential replacement. While the initial intent of this Cess was to compensate States for revenue losses during the first five years of GST, the pandemic-induced economic downturn led to its extension till March 2026. While discouraging the consumption of certain goods through taxation is a valid strategy, any new cess should be introduced as part of a broader GST rationalization effort. Despite the commendable steps taken by the Council, the GST regime still requires comprehensive reform. The ongoing exclusion of items like electricity, petroleum, and alcohol from the GST net is a glaring omission. While addressing immediate concerns is crucial, the Council must also focus on a holistic reform plan for the GST, ensuring it truly becomes the 'Good and Simple Tax' it was envisioned to be.

celebration of the passing of the Women's Reservation Bill by both Houses of Parliament glosses over certain realities about this conditional legislation. The conduct of a census in the country followed by a delimitation of constituencies based on this census are the conditions for this legislation to take effect. Once it is accepted that reservation for women in legislative bodies is a progressive measure, there is no legal or political justification to prolong its implementation.

Speaking in the Lok Sabha, Home Minister Amit Shah justified these conditions saying that there could be legal challenges against the legislation if it is passed without relying on criteria fixed by way of a process of delimitation. No doubt, a legislation should be based on a solid foundation, and have valid reasons for existence. In the case of the Women's Reservation Law, the reality is that about half of the population are women and they are under-represented in Parliament and State legislative bodies. Reports show that, of the maximum allowed 550 seats in the Lok Sabha, only 82, i.e., 15% are represented by women, and out of the 250 members in the Rajya Sabha, only 31, i.e., 12% are women. The Global Gender Gap Report places this in a macroscopic context by showing that India ranks 141 out of 185 in its list.

Contentious issue

Article 81(2)(a) of the Constitution states that the number of seats in the Lok Sabha for a State should have a co-relation with the population of the State and "so far as practicable", the criteria should be the same for all States. Article 170, concerning the legislative Assemblies of States, also takes population as the basis for designing constituencies. However, delimitation in India is a con-



tentious issue. It acts as an incentive for population expansion with scant regard to development and family planning. This was why a full-fledged delimitation was kept in abevance in India since 1976. It is now expected to be carried out after the Census which will only be held by 2026 at the earliest.

But, as scholar Nilakantan R.S. predicts, this "demographic detonation" will cause "another big fork in the future allocation of political power and associated resources between the north and south". In his book South vs North (2022), Mr. Nilakantan has demonstrated how South India has performed well in sectors such as health, education, economy etc. in comparison to the North. South Indian States reduced their population by scientific means whereas North Indian States in general and States such as Uttar Pradesh and Bihar in particular have failed to do so. The South Indian States have raised concerns about this proposed delimitation. This could lead to two outcomes: the delimitation would get prolonged by years which in turn will defer the materialisation

of the women's quota law, or it might happen based on population which in turn could translate to undue advantages for certain States in the North.

These are situations that the relevant provisions in the Constitution, namely Articles 81 and 170, failed to foresee. Thus, Parliament has committed an egregious folly in fusing women's reservation with delimitation.

Articles 330 and 332 of the Constitution deal with the reservation of the Scheduled Caste/Scheduled Tribe (SC/ST) in the Lok Sabha and the Legislative Assembly of States respectively. Though these Articles mention the relationship between reservation and the population of the SC and ST groups, such a parameter is irrelevant to women's quota. That their share in the total population is almost 50% is undisputed. Further, there cannot be a drastic variation in their population from one constituency to the other, as it could happen with SC or ST.

Unwarranted conditions

A census to understand the population

purpose of the Women's Reservation Bill are qualitatively different from those of the delimitation exercise. And, reservation for women in local bodies, which materialised through the 73rd and 74th Amendment Acts of the Constitution, and came into effect in 1993, was not contingent on any delimitation exercise for that purpose. Parliament, however, has lost sight of these aspects.

How far a constitutional Amendment can be done by way of contingent legislation is an issue too, as certainty is regarded as one of the hallmarks of modern constitutions. In Hamdard Dawakhana vs Union of India (1959), the Supreme Court hinted that in conditional legislations, for the statute to take effect, there could be a further dependence on the executive or even on the legislature of the future day, among other things.

Such enactments might be needed on various occasions for multiple reasons. But, by amalgamating the demand for women's reservation with the uncertainty of a future delimitation process, that too in the case of a constitutional amendment, Parliament has made populist rhetoric at best or committed a constitutional blunder at worst. The secrecy maintained on the subject till the commencement of the special session was also thoroughly undemocratic, which in turn, prevented the exposure of the follies of the legislation.

Therefore, with regard to the future of the women's quota in the legislature, one can only have the pessimism of the intelligence and optimism of the will, as Antonio Gramsci famously put it, in a different context.

The end of the two-state solution



e answer was always known; it was the question that had been unclear. From the very beginning of the Jewish-Arab conflict, the only viable long-term solution has been to divide the land between the Jordan River and the Mediterranean Sea by creating two countries for two people.

Both the Arabs and Jews have had strong self-conceptions of nationhood tied to the same land — self-conceptions that did not reckon for the other. But for much of this 100-year war, Jews accepted the inevitability of partition while the Arabs rejected it. For the last few decades, however, the situation seems to have been reversed. One section of the Palestinian leadership, much of the Arab world, and all of the West seem to have agreed on a two-state solution, while it is Israel that is balking at creating a sovereign Palestinian state in West Bank and Gaza, with its capital in East Jerusalem. Understanding its reason central to predicting the cor Hamas's recent terror attacks on Israel, one that has killed more than 700 Israelis and provoked the Israeli response. At first glance, there seem to be many stakeholders to this never-ending conflict such as the Palestinian people, the multiple Palestinian leaderships of Hamas, Islamic Jihad and the Palestinian Authority, the Israeli voters, the Israeli government with its many coalition partners, the Arab countries, Iran, the West led by the U.S., and now even China. From a position of justice, one could argue that the only two stakeholders who should matter are the Palestinian and

But as a matter of realpolitik, the key stakeholder has always been the Israeli public. This is because, without the acquiescence of the more powerful Israel, no solution is possible. And since Israel is a democracy, without the



agreement of the Israeli public no Israeli acquiescence is possible. So, the only question to ask is: will Hamas's attacks push the Israeli public into creating a sovereign Palestinian state?

Some opinion-makers think so. They feel that Israel's trauma from Hamas's strikes a sovereign Palestinian state is a prerequisite for peace. But it is more likely that Israelis will come to the opposite conclusion: that a two-state solution — one where a Palestinian state will have its own Army and security — will empower Palestinians to attack Israel even more effectively. They fear that an independent Palestine will behave as Hamas has been

Hamas's stance

Hamas does not accept Israel's right to exist in any shape. It attacked Israel on its southern borders that will remain with Israel in any eventual peace deal, and killed and abducted innocent civilians, not religious settlers occupying the West Bank. The attack was directed at the very existence of Israel as a Jewish state. That the supposedly moderate Palestinian Authority in the West Bank has supported Hamas will only heighten Israeli fears that an end to the conflict will not be a Palestinian and Jewish state living side by side, but a single Palestinian state between the river and the sea. This is not a semantic of her country under some circumstances, but in no circumstances will she accept its annihilation. The central obstruction to a two-state solution has not been the Israeli occupation of West Bank and Gaza — there was after all a murderous conflict between the two sides even before the occupation in 1967. The main roadblock has been the inability of the Palestinians to convince Israeli voters that if given sovereignty in some part of the land, they would leave the Jews alone in the other. There has always been a radical Israeli

fringe unwilling to see the Palestinians as a people deserving a state. These religious bigots had historically been on the margins of Israeli politics. Today, they are key members of the ruling coalition, reflecting a widening distrust among Israeli voters of Palestinians as partners in any eventual peace.

The lesson Palestinians have learnt from their decades-long occupation and daily humiliations has been that Israeli civilians need to share their pain to force them to reduce it. But from the Israeli perspective, every wave of violence against their civilian community has made them less likely to risk ending the occupation of Palestinians. The recent terror attacks will further Israeli suspicions that if this is what Hamas can do with a tiny bit of power, what would they do to Israel with overeign state power?

Hamas' unprecedented attack will reinforce among Israelis the only two options they feel they have: they can either endure the continuing moral shame of ruling over another people or they can risk their very existence by creating a sovereign Palestinian state that might then wipe out Israel as a Jewish state.

Given the power imbalance between Israel and the rest of the Arab world, there is only state. That will be to convince Israeli voters that an eventual Palestine will live peaceably next to Israel. But for this generation of Israelis who are scarred by images of a kidnapped 84-year-old grandmother being paraded in a golf cart by Hamas, the immorality of occupying another people will be preferable to risking the annihilation of one's own people. The only way forward is for a Palestinian leadership that can credibly signal to the Israeli people that it will not use the freedoms it gains from any peace deal to hurt Israel. The prospects for that seem dim.

The G20 Roadmap on Crypto Assets adopted by the G20 Finance Ministers was spelt out in a Synthesis Paper prepared jointly by the International Monetary Fund (IMF) and Financial Stability Board (FSB). "We adopt the roadmap pro-

posed in the Synthesis Paper as a G20 Roadmap on Crypto Assets...We call for swift and coordinated implementation of the G20 Roadmap, including implementation of policy frameworks; outreach beyond G20 jurisdictions; global coordination, cooperation and information sharing; and addressing data gaps," said a communique issued during the fourth meeting of the FMCBG on Thursday.

The Finance Ministers and Central Bank Governors (FM-CBG) of G20 nations met on the sidelines of IMF-World Bank annual meetings in Marrakesh,



However, the communique made no mention of the ongoing Israel-Hamas war. At least 2,800 people in Israel and Gaza have been killed in the conflict, with thousands of others injured since October 6.

HDFC Bank to report Imports from Russia up 67 pc to USD 30.42 bn in Apr-Sep

NEW DELHI: India's imports from Russia rose by about 67 per cent to USD 30.42 billion during the April-September period this fiscal on higher shipments of crude oil and fertiliser, according to the commerce ministry data. With this, Russia has become

India's second-largest import source during the first half of this fiscal. The imports were USD 18.24 billion during April-September 2022. From a market share of less than 1 per cent in India's import basket before the start of the Russia-Ukraine conflict, Russia's share of India's oil imports rose to over 40 per cent. India, the world's thirdlargest crude importer after China and the United States, has been buying Russian oil that was available at a discount after some countries in the West shunned it as a means of punishing Moscow for the invasion of Ukraine.

The ministry's data showed that imports from China dipped to USD 50.47 billion during the period against USD 52.42 billion in the same period

Similarly, imports from the US declined to USD 21.39 billion during the period under review from USD 25.79 billion in April-September last

year. Imports from the UAE contracted to USD 20.7 billion during April-September 2023 compared to USD 27.8 billion a year ago. During the first half of this fiscal, imports also dipped from Saudi Arabia, Iraq, Indonesia, Singapore and Korea. Among all the top ten import source nations of India, imports from Hong Kong increased to USD 10.21 billion as against USD 10 billion in April-September 2022.

On the export front, India's exports to seven of its top 10 destinations have recorded a negative growth rate during



the period. During the first six months of this fiscal, the country's merchandise exports to the US, the UAE, China, Singapore, Germany, Saudi Arabia, and Bangladesh have dipped. However, exports to the UK, Australia and the Netherlands have recorded positive growth.

India's merchandise exports contracted by 2.6 per cent to USD 34.47 billion in September even as the country's merchandise trade deficit narrowed to USD 19.37 billion during the month under review, according to the government data released

Govt extends 20 pc export duty on parboiled rice till March 31 next year



The finance ministry through a notification extended the duty till March 31, 2024. With these curbs, India has now imposed restrictions on all varieties on non-basmati rice. Non-basmati white rice constitutes about 25 per cent of the total rice exported from the country. In July, the government

banned export of non-basmati white rice to boost domestic supply and keep retail prices under check during the upcoming festive season. In September last year, exports of broken rice were prohibited. In the April-June period this fiscal, about 15.54 lakh tonnes of non-basmati white rice was exported against only 11.55 lakh tonnes



in the year-ago period. The ban on exports of non-

basmati white rice was imposed due to the rise in prices of the foodgrain and higher exports. The annual retail or consumer price inflation was at a threemonth low of 5.02 per cent in September. India's total exports of basmati rice stood at USD 4.8 billion in 2022-23, while in volume terms it was at 45.6 lakh tonnes. Exports of non-basmati stood at USD 6.36 billion in the last fiscal. 

NEW DELHI: World Trade Organization's (WTO) Chief Ngozi Okonjo-Iweala has warned that Israel-Hamas conflict could have a "really big impact" on already weak global trade flows if it widened throughout the region.

Hoping the Israel-Hamas conflict could be ended quickly, Okonjo-Iweala made this statement while she in Mo-

annual meetings of the International Monetary Fund and World Bank.

"Middle East violence could add to factors throttling trade growth, including higher interest rates, a strained Chinese property market and Russia's war in Ukraine," said the chief.

"We hope this ends soon and it's contained. Our biggest

Okonjo-Iweala said global uncertainty was already limiting growth in trade, but that would be exacerbated by the sudden onset of war between Israel and the Islamist Hamas group that controls the Gaza

The Geneva-based trade body last week halved its growth forecast for global goods trade this year, citing persistent inflation, higher interest rates, the slowing Chinese economy and the war in Ukraine. The WTO said merchandise trade volumes would increase by just 0.8% in 2023, compared with its April estimate of 1.7%

For 2024, it said goods trade growth would be 3.3%, a forecast virtually unchanged from its April estimate of 3.2%.

Speakers and presiding officers of the parliaments of G-20 countries are participating in this conference. However, Canada has maintained distance itself from it to avoid further controversy.

It is believed that Canada has decided not to attend the conference to avoid discussing this matter after the souring of relations with India after the killing of Khalistani terrorist Nijjar. Regarding this, it has been told by the Ministry of External Affairs that Canadian representatives will not attend P20. All leaders and all countries have been invited to participate in it.

Let us tell you that earlier Lok Sabha Speaker Om Birla had said that India will raise all the issues with the Canadian President of the Senate during the upcoming Parliament-20 meeting of the presiding officers of G20 countries. It was believed that he would also raise the issue of Khalistanis thriving in Canada. Canadian speaker Raymonde Gagné had also confirmed her participation in the conference. But now his spokesperson said that he will not be able to attend the conference. They were not even told the reason for this also.

India's foreign ministry has confirmed the meeting of two ing to the British newspaper Financial Times, Canadian Foreign Minister, Melanie Jolie had a secret meeting with Indian Foreign Minister, S Jaishankar in Washington a few days ago, amid a diplomatic standoff between the two countries over Canada's allegations of India's involvement in the killing of Khalistani activist Hardeep Singh Nijjar.

The report also stated that the Canadian government was making efforts to resolve the tense diplomatic situation with New Delhi, following the reports said that Canadian diplomats were given a deadline to leave India or take risk losing their diplomatic immunity. The Canadian foreign minister said earlier this month that they were trying to resolve the issue privately. Canadian Prime Minister

Justin Trudeau also said that his country does not want to "escalate the strain situation" with India and affirmed that the Canada will continue to "engage responsible and constructive relationships with India".

A recent report by Canada's CTV News mentioned that the country already has transferred around 30 diplomatic embassy staff members from India to either Kuala Lumpur or Singapore. Needless to mention, relations between India and Canada deteriorated after Trudeau alleged that the Indian security agent's "possible" involvement in the killing of Khalistani criminal Hardeep Singh Nijjar in British Columbia on September 19. On June 18, Nijjar was shot dead by two masked gunmen and Hardeep Singh Nijjar was a Canadian citizen.

Rejecting the allegations, India's Ministry of External Affairs reacted strongly and described the allegations as "absurd" and "influenced". In a sharp reaction to Canada's expulsion of an Indian embassy official, New Delhi had also expelled a senior Canadian diplomat.

India shines at the **Asian Games**

India excelled at the 2023 Asian Games, winning a total of 107 medals. At the same time, Pakistan could win only three medals in the competition. In 1958, India won only 13 medals while Pakistan bagged 26. Since then, India>s performance has steadily improved while Pakistan>s has deteriorated.

The 2023 Asian Games have been finished. The Indian athletes have returned to their country where they were warmly welcomed by their countrymen.

Pakistan has won a total of three medals at the 2023 Asian Games. These include one silver and two bronze medals. Pakistan had last won gold in this competition in 2014. At the same time, India won 28 gold medals that year. Currently, Pakistan>s performance may be very poor compared to India, but there was a time when Pakistan won twice as many medals as India.

The Asian Games were held for the first time in 1951. India had won 51 medals in the competition held in New Delhi. Pakistan did not participate in this competition. Thereafter, India>s performance declined in 1954 and India received only 17 medals. At the same time, Paki-



Games for the first time and won 13 medals. In 1958, India had its worst performance in the Asian Games and could win only 13 medals. This time Pakistan won 26 medals, exactly twice as many as India. After that, in 1962, Pakistan won 28 medals and India 33 medals. Pakistan>s performance started to decline in 1970, and India>s performance continued to improve.

Until 2002, Pakistan always won about 10 medals, but this number never exceeded 17. At the same time, India continued to improve its performance during this period. India, which usually wins 20 to 30 medals, won 57 medals in 1982. This was the country's best performance at that time. From 1998 onwards, India>s medal consistency improved and the number of medals was above 30 from then on. At the 2006 Asian Games, India won 53 medals

Healthcare experts across the country are reporting a sharp increase in knee Osteoarthritis in the younger population, a condition typically associated with ageing. While joint pain at any age is known to negatively affect the overall well-being and productivity, early onset is bringing an altogether different set of challenges to deal with.

"Of late I have been receiving patients as young as 40-41, complaining of severe knee pain and work absenteeism. Unlike elderly knee osteoarthritis patients, who are more into pain management, this young working lot is focussed on complete and quick recovery so that they could resume work as soon as possible. In cut-throat competition, they cannot afford low productivity in their working

reported to cause loss of productivity and a poor career growth at the prime of career1, it also increases apprehension concerning financial obligations and makes it difficult for the patients to sustain a normal family and social life.

Rise in knee osteoarthritis in the younger population is surprising as it is a condition which develops due to wear and tear of weight bearing joints,

mostly due to ageing. According to the doctors, Knee Osteoarthritis triggers due to some morphological and biochemical changes in the knee joints, creating a gap between the joints that leads to abrasion and joint degeneration, a classical symptom of ageing. And even in the older age, doctors believe that regulating certain modifiable risk factors, like increasing physical activity, maintaining a healthy weight, ensuring an optimum sun exposure and refraining

from substance abuse, like topacco and alcohol, could help delay or completely eliminate

thritis at an unusual age seeks explanation, Dr Tomar says, "An early onset of degenerative joint disease simply means that factors like unhealthy lifestyle, obesity, lack of sun exposure and substance abuse played their part way too well.

According to the American Journal of Clinical Nutrition, another reason for weak bones in young age is an excessive intake of caffeinated drinks, especially in childhood and adoscence2. According to a study published in PubMed3 more han ninety percent of total bone mineral content (BMC) is generated before the age of vears, so technically the stage for weaker joints is set at an early age. Clearly, we are falling short

in ensuring bone health at almost every front, leading to a sharp rise in knee arthritis in working age.

As far the treatment of knee osteoarthritis in younger patients, it depends entirely on the stage of the disease, explains Dr Tomar, "At an early stage we prefer medication and lifestyle modification. Usually attaining a healthy body weight, ensuring doctorassisted physical activity and improving bone density by diet and supplements helps with pain, and sometimes even stops joint degeneration. However, for the patients with chronic pain and advanced osteoarthritis, when such interventions are late to work, knee replacement surgery offers a sustainable solution."
