ED summons politically motivated, illegal: Arvind Kejriwal

Delhi Chief Minister Arvind Kejriwal has sent his reply to the ED summons, calling them illegal and politically motivated, AAP sources said on Thursday. Kejriwal was summoned by the Enforcement Directorate for questioning in the excise policy-linked money laundering case on Thursday. However, he left for an undisclosed location for a 10-day Vipassana meditation course on Wednesday.

"Kejriwal called the fresh summons politically motivated and illegal. In his reply, he said that he has lived his life through transparency and honesty and has nothing to hide. He said he is ready to accept any legal summons,' sources said, citing his reply. Kejriwal was scheduled to leave for the Vipassana course on Tuesday but could not do so as he was busy with the INDIA bloc meeting. He left at around

1.30 pm on Wednesday for

the pre-scheduled meditation

course, officials said. The Aam Aadmi Party on Tuesday questioned the timing of the summons, saying the party's lawyers are studying the notice and "legally correct" steps will be taken.

They said Kejriwal's Vipassana session was "pre-sched-

uled" and the information was in the public domain.

"Everyone knows the chief minister is leaving for Vipassana on December 19. He regularly goes for this meditation course. It's a pre-scheduled and pre-announced plan," AAP MP Raghav Chadha had said.

Earlier, Kejriwal was summoned by the ED on November 2 but he skipped the questioning alleging the notice was illegal and politically mo-

Govt extends zero import duty & agri-cess exemption on masur till March 2025

NEW DELHI: The government has extended current effective zero import duty on masur dal (lentil) till March 2025 in order to ensure steady supply of the key pulse from international market and keep domestic prices under check.

However, the government has not extended the current import duty structure on three crude edible oils - palm oil, soyabean oil and sunflower oil.

According to a finance ministry notification, the exemption of zero import duty on masur as well as agri-infra cess of 10 per cent has been extended till March 2025.

In some of the pulses, we don't produce as much as we consume. For stability of import policy, the current exemption has been extended on masur till March 2025 so that farmers of the producing countries get clear signal from India and plan their sowing,

Consumer Affairs Secretary

Rohit Kumar Singh told to news agency. The basic import duty on

masur was reduced to zero in July 2021, while the exemption from 10 per cent agri-infrastructure cess was given in February 2022. Since then, it was extended multiple times and currently was valid till March 2024.A finance ministry official said that the notification is only for extending zero duty and exemption of agri-infra cess for masur alone, not three crude edible oils.India is the world's largest producer and import of pulses. It imported 24.96 lakh tonnes

Register your property anywhere in Delhi says, Revenue Minister Atishi

Properties in Delhi can be registered at any sub-registrar's office, Revenue Minister Atishi announcing the 'Anywhere Registration' policy.

The policy will save people from long queues for property registration, thus promoting transparency to help curb corruption, she added.

Chief Minister Arvind Kejriwal has approved the policy and the file has been sent to the Lt Governor for notification.

The Delhi government's Revenue Department has decided to introduce the 'Anywhere Registration' policy, according to a statement issued later in the day.

According to the policy, people wanting to register their properties can go to any subregistrar's office in Delhi. Individuals will not be restricted to

a specific sub-registrar's office for property registration, it said.

Many complaints about the sub-registrar's office often reach Kejriwal, the statement added.

One complaint received is that there are long queues in many sub-registrar's offices. Another complaint that is often received is regarding the prevalent corruption in many such offices, the statement said.

"There are middlemen outside the offices who demand money and people are forced to pay these middlemen to get their registry work done in the same office. To address these issues, the Revenue Department has initiated this new policy," added the statement.

All sub-registrars in Delhi will now function as joint subregistrars and their jurisdiction will cover the entirety of Delhi. Anyone residing in Delhi can make an online appointment for property registration at any of Delhi's 22 sub-registrar offices,


The attack occurred as the personnel were en route to a cordon-and-search operation. According to army sources, the curve at Dhatvar Morh be tween Dera Ki Gali around

Olympic medallist grappler Bajrang Punia on Friday decided to return the Padma Shri award in protest over the election of Sanjay Singh, a Brij Bhushan Sharan Singh loyalist, as the president of Wrestling Federation of India (WFI). "I am returning my Pad-

mashree award to the Prime Minister. This is just my letter to say. This is my statement," read a post shared by the Tokyo Olympics bronze medallist wrestler on X, formerly Twitter. On Thursday, Sanjay was

elected as the president of the WFI after the panel led by the close aide of Brij Bhushan won 13 of the 15 posts. Sakshi Malik, Bajrang and Vinesh Phogat addressed a press conference after Sanjay's election in which Sakshi, a bronze medallist at the 2016 Rio Olympics, announced that she would quit the sport as a mark of protest.


In a letter addressed to Prime Minister Narendra Modi, Bajrang wrote: "Dear PM Ji, hope your health is well. You must be busy in many work but I am writing this

Bill, 2023 makes the process of allotment of title and registration of periodicals simple and simultaneous, through an online system without the requirement of any physical interface. This would enable the Press Registrar General to fast track the process, thereby ensuring that publishers, especially small and medium publishers, face little difficulty in starting a publication. Most importantly, the publishers would no longer be required to file a declaration with the District Magistrates or the local authorities and get such declarations authenticated. Furthermore, printing presses would also not be required to furnish any such declaration; instead only an intimation would

be sufficient. The entire process

Lok Sabha, Minister for Information & Broadcasting Anurag Singh Thakur said "the Bill reflects yet another step of the Modi Government to wards jettisoning mentality of slavery and bringing new laws for new India". The Minister further added that it has been the priority of the Government to end criminality, improve ease of doing business and ease of living through new laws and accordingly, efforts have been made to substantially decriminalize the colonial era statute. The ruling Aam Aadmi Party is facing a tough time after most of its leaders are facing corruption and court charges. Whether former deputy Chief Minister Manish Sisodia, Rajya Sabha member Sanjay Singh, former Delhi minister Satyendar Jain, etc. - the absence of the party leadership raises the question of who will be able to hold this party together.

According to sources, Union Home ministry has given its in-principle approval to hand over the security of the Parliament building to CISF security and fire-fighting forces following the Government Buildings Act. Incidentally, both Delhi Police and CISF are controlled by Amit Shah>s ministry.

A glass wall will install between the main floor of the house and the audience seats. It has also been decided to increase the number of security guards during the session to prevent reckless behavior by the audience, a source in the Lok Sabha Secretariat said. Parliament will remain closed to visitors until new security measures are put in place. Apart from this, the proposal calls for speedy introduction of smart cards for entry of MPs.



NOIDA: Uttar Pradesh Chief Minister Yogi Adityanath has asked authorities in Gautam Buddha Nagar district to resolve disputes between builders and homebuyers as soon as possible.

The Chief Minister gave necessary instructions to officials taking cognizance of the issues faced by homebuyers in Noida, Greater Noida and Greater Noida West during his visit to the district on December 8.

Major issues that are being faced by several homebuyers in the district include delayed possession; problems in getting registries done; disputes with builders over maintenance; and disputes over the formation of apartment owners' associations (AOAs), among others. The Chief Minister directed officials to expedite the property

registration process. He also sought information from officials of Noida, Greater Noida and Yamuna Expressway Industrial Development Authority about the current status of various disputes be-

In Greater Noida, the committee constituted by the Authority to resolve builderbuyer disputes held a meeting on December 12 to provide rights to the flat buyers.

In the meeting, discussions were held to find solutions to the issues like completion of the incomplete project, formation of AOAs in societies, and transfer of interest-free maintenance security (IFMS) fund of the society, among others.

"There will be a passportlike verification system in place for those wanting their first Aadhaar after 18 years, " said an official from UIDAL

The state government will appoint nodal officers, additional district magistrates, at the district and sub-divisional levels for this purpose, the of-

The Aadhaar facility for such individuals will be available at selected centres, including the main post office of each district and other Aadhaar centres identified by the UIDAI.

All Aadhaar requests from this category of people will go through data quality checks and then be routed for verification through the service portal. The Sub-Divisional Magistrates will ensure verification of all requests received at the



service portal, and Aadhaar will be generated within 180 days of clearance.

The proposed criminal law bills have been under scrutiny, with concerns raised previously by opposition leaders such as Adhir Ranjan Choudhary and Senior Advocate & Former Minister & MP Kapil Sibal, who have highlighted potential violations of human rights and the inadequacy of safeguards against excesses by law enforcement agencies. The members of the ruling Bharatiya Janata Party (BJP) and its allies, however, have defended the bills, saying that while the extant British-era criminal laws are centred around punishment and deterrence, the proposed bills shift the emphasis to justice and reformation, keeping with the

changing needs of modern-day India. Endorsing the bills, Biju Janata Dal legislator Bhartruhari Mahtab reasoned during the debate on the bills, «It is imperative that our outlook is changed and that law and order is viewed outside the

colonial lens.»

BJP Member of Parliament (MP) Tejasvi Surya, explained that the bills are an attempt to make the citizen the centre of the criminal justice system. «Swarajya has finally attained true meaning because our country is moving towards respecting swabhasha, swadharma, and swadesha,» the said. The bills focus on digitisation and information and communication technology, among other things, gained the members> approval. «This is the age of communication and technology, and communication and technology is power,» said senior advocate and former law minister Ravi Shankar Prasad.

Prasad pointed out that while there were 511 sections in the IPC, the corresponding new bill has 356. He said while 176 sections have been changed completely, eight new have been added. He also

have been deleted.

Dissenting voices were also conspicuously absent, apart from a handful of opposition members. Notably, All India Majlis-e-Ittehadul Muslimeen MP Asaduddin Owaisi raised concerns over the prejudice in the implementation of criminal laws against religious minorities and other vulnerable communities like Dalits and Adivasis. He also voiced his apprehensions about a provision in the Bharatiya Nagarik Suraksha Sanhita allowing police custody beyond 15 days, pointing to potential violation of civil liberties.

Lok Sabha took up the bills, with some MPs saying these will provide justice rather than punishment and others pointing to "loopholes" that they claimed will give discretionary powers to enforcement

Shah said, he had held at east 158 meetings with regard to the three new bills and personally checked all of them in detail. "I have gone through every comma, full stop of the new criminal laws," he added.

The minister said there will be no argument on "saving' terrorists. 

Telecom Bill should balance progress and privacy

he introduction of the Telecommunications Bill, 2023, marks a significant stride in the Union government's ongoing efforts to reshape and modernize the regulatory framework for wireless networks and Internet service providers. This 46-page statute, while retaining the core of existing regulatory structures, introduces commendable simplifications in bureaucratic procedures such as applying for licences and permits for telecom operators. The move towards digitizing licensing processes is a welcome development, offering telecom operators streamlined channels for compliance, dispute resolution, and the establishment of infrastructure on both public and private properties. A notable relief comes for the satellite Internet industry, which now finds itself free from the burden of bidding for spectrum. This decision aligns India with global practices and opens promising avenues for remote area connectivity. Industry bodies have rightly lauded the Bill for streamlining their regulatory landscape and enhancing ease of doing business, laying a foundation for the next phase of telecom expansion. Given that over half of India's population is still on the fringes of digital connectivity, this Bill could be a gamechanger. However, the Bill is not without its challenges. Its broad definition of telecom services encompasses a wide range of services, inadvertently raising concerns about state authority, privacy, and surveillance. These apprehensions are not unfounded, especially in light of past allegations of state-sponsored snooping. Although the Bill attempts to address issues like spamming, the solutions proposed seem to require compromises to privacy, a trade-off that needs careful consideration. The Bill, in its current form, grants significant powers to the government. This necessitates a commitment to transparency and public consultation, particularly since many of the Act's provisions hinge on subordinate legislation by the Department of Telecommunications. The government must approach these concerns with an open and consultative mindset, ensuring that the regulatory framework for the digital age is robust, fair, and respectful of individual rights.

Defence budgeting and the deterrence point

(MMRCA) programme of the Indian Air Force (IAF) earned the sobriquet of being the 'mother of all procurements' due its cost, pegged at around \$10 billion in 2007. A decade later, the purchase of 36 Rafale jets was of limited value because the requirement was for 126 aircraft. Consequently, many IAF chiefs have spoken of the depleting squadron strength in the IAF, which is now an abysmal 32. It would take another 10 years before it reaches 35 squadrons, as stated by the current IAF chief. The Indian Army and the Indian Navy fare no better either with the media reporting major deficiencies with them too. With India in election mode and sops being showered on the electorate (even more certain before the general election in 2024), the allocation for defence in Budget 2024-25, which starts getting planned now, could take a hit. This could impact India's deterrence posture, which defence preparedness is all about.

Need for judicious assessment

The question is whether 'affordable defence' - due to the perennial guns versus butter dilemma — will be the driving factor. Or, will 'affordable effectiveness' drive the defence Budget allocation? This is best illustrated by the IAF going in for 97 more Tejas Mk1A fighters to overcome the deficit in squadron strength, though this was to be achieved by the 114 multi role fighter aircraft project that the IAF has been pushing for. So, to rephrase the question, should Budget (allocation) be allowed to determine defence potency (remember General V.P. Malik's quip during the Kargil conflict: "We will fight with what we have")? Or, should the required potency drive allocations for defence?

The threat on the northern borders is a



dismiss our western neighbour's present benign stance as indicative of a lessening of risk. India needs to be prepared for both. The imperativeness of a judicious assessment of how India plans to prosecute the next war could not be more pressing in these days of electoral one-upmanship.

Enough has been written on the inescapable necessity of accretion in sea power to deter China in the environs of the Malacca Strait and further east, as also in the Indian Ocean. The Army needs to modernise too and, considering its size, the Budget requirement would be considerable. The planning and budgeting in the Indian military before the Russia-Ukraine war was for a short sharp conflict. The logistics design was to stock up on 10i (10 days intense) war, and build up to a 40i scenario. The refrain has changed, with the leadership of the armed forces now visualising an extended war scenario, as seen in Ukraine. It is here that a recent prescient article in the authoritative website, War on the Rocks, titled 'You go to

ou have, not the industrial base you want', weighsin on the debate with its clairvoyant deductions, and needs to be studied given the publicity around the Atmanirbhar Bharat drive.

The indigenous drive, R&D

It needs no reiteration that the armed forces should be technologically modern at any given time. However, developing a local defence industry takes decades, necessitating a smart balance to be maintained between

imports and indigenous accretions to ensure the required potency. The Atmanirbhar Bharat public relations drive notwithstanding, a hard clinical view is required on the realities of the armament supply chain that would be in place in the near to mid-term

India's defence Budget, in real terms, has been more or less stagnant. Defence expenditure (revenue and capital), as a percentage of central government expenditure, has been declining — from around 16.4% in 2012-13 to 13.3% in 2022-23. The Ministry of Defence had asked for Rs 1,76,346 crore in 2023-24 for capital acquisitions but only Rs 1,62,600 crore was allotted, creating a deficit of Rs 13,746 crore.

In the sphere of research and development, the picture is not rosy either. The Global Innovation Index 2022 pegs India's research and development expenditure at just 0.7% of its GDP which places it 53rd globally. China, incidentally, spent \$421 billion in 2022, which is 2.54% of its GDP. Though the research and development good that 25% of the allocation was for he private sector

The government's emphasis on indigenisation through the Innovations For Defence Excellence (iDEX) scheme and service-specific projects such as the Baba Mehar Singh competition for unmanned aerial vehicles by the IAF, and similar ones in the other two services, are laudable.

Similarly, the restructuring of the Ord nance Factory Board and promulgation of negative lists for imports instil confidence in the private sector for assured contracts. While all these are welcome, and the increase in defence exports heartening, it must be accepted that this drive still has a long gestation period. The momentum should be sustained with a continuum in policy making and adequate defence budgeting by making them election-proof in our boisterous democracy — bipartisan statesmanship would be key in this endeavour.

Costs are important and one must not spend scarce monies to face a 10 feet tall adversary when a pygmy exists on the other side. But what if there are two of them. both militarily adept, and not pygmies? And, India is not 10 ft tall either. China's belligerence has resulted in the doubling of Japan's defence budget, the increased arming of Taiwan by the United States, a reshaping of regional alliances and a historic U.S.-South Korea-Japan summit. It would be naive, nay unprofessional, if our defence Budget is not given its due and national security imperatives overridden by electoral imperatives.

HARISH S. WANKHEDE EXPLAINS HOW BJP'S 'SUBALTERN HINDUTVA' IS A STRATEGIC SUCCESS, BUT LACKS BROADER SOCIAL IMPACT

Subaltern rise: How BJP is reshaping Indian political arena



n the recent Assembly elections in Rajasthan, Madhya Pradesh and Chhattisgarh, statistical analysis by the Centre for the Study of Developing Societies shows that a significant section among the Scheduled Castes (SCs), Scheduled Tribes (STs) and Other Backward Classes (OBCs) backed the Bharatiya Janata Party (BJP), thus making the party a formidable force in democratic battles. It is an important development as just a decade ago, the BJP was often cornered by the Opposition as being the party of the social elites. With the arrival of Narendra Modi as the Prime Minister of India, there has been an elevation of the party as one for the socially marginalised Hindu masses — a phenomenon now understood under the Subaltern Hindutva' rubric In north India's Rajasthan, Madhya

Pradesh, Uttar Pradesh, Haryana and Chhatforce. These are also the States where the population of OBCs, SCs and the STs is above the national average. In the last two decades, the BJP has successfully mobilised these groups through innovative political strategies and by curating influential cultural events. However, the actual benefits of economic developments and political change have been overtly controlled by the conventional social elites, a development that often relegates the Dalit-Bahujan masses as passive peripheral spectators in the rapid elevation of the rightwing. With the general election to be held next year, the party should address the issues of social discrimination and economic injustice more sensitively.

Outlining the party's strategy

There are three fronts to the BJP's mobili-



sation strategies towards the Dalit-Bahujan masses. First, marginalised social groups will benefit from general welfare measures (freebies, loan waivers, women-centric policy benefits) and the government will provide he poor (free fo without identifying them on the basis of caste. Second, the BJP has alleged that dominant OBC castes (Yadavs in Uttar Pradesh and Bihar) have exploited social justice policies, and, therefore, a special reservation quota should be mooted for the Extremely Backward Classes (EBCs). Third, the BJP engages the lower strata through curating emotive narratives about their history, icons and caste pride, using various religious events and cultural fronts influenced by the BJP. On the flip side, the actual issues of substantive land distributions for the landless communities, representation of the Dalit-Bahujan groups in the high echelons of power and their participation in the neo-liberal economic growth as major shareholders do not form the mainstream discussions within the BJP's 'Subaltern Hindutva' strategies

The Bihar caste report

Bihar's Caste Survey report, that was released recently, shows that the worst-off social groups, especially EBCs, still face precarious economic conditions, social insecurities and are distanced from the basic human entitlements. It is apparent that EBCs and Dalits in other States face similar conditions. However, the BJP is yet to engage with these issues and has not offered much resolutions to contest the prevalent issues of poverty, social backwardness and landlessness. The 'Subaltern Hindutva', while appearing to be mainly strategic in ensuring the BJP's electoral victories, offers no mandate to satisfy the aspirations of the worst-off social groups.

With Vishnu Deo Sai and Mohan Yadav as the Chief Ministers of Chhattisgarh and Madhya Pradesh, respectively, the BJP has demonstrated its willingness to promote ip from the su initiating a process of democratisation of the top political positions. Such initiatives should also be supplemented by effective policies for the empowerment and participation of the marginalised social groups in the economic

development and social change.

The BJP must pass the social justice test as sections among the historically disadvantaged have moved to the BJP with deep expectations for their economic welfare and elevated political participation. In Madhya Pradesh and Chhattisgarh, while the combined population of Dalits and Adivasis is close to 40%, their share in political power (cabinet ministership and other important portfolios) is negligible. Similarly, EBCs are another neglected group when it comes to the distribution of important political assets. The social elites, though small in number, remain the torchbearers of

Hindutva's developmental agenda.

Second, the BJP should also ensure that a new impressive class among Dalits and Adivasis should emerge as the new leaders. business entrepreneurs and influencers in the economic sphere. Such a directive will radicalise the conventional social justice policies that often address Dalit-Adivasi groups as the passive recipients of the state's welfare packages. Instead, Dalits and Adivasis should be identified as the essential components of neo-liberal economic development and have an equitable share in the profits of urbanisation, industrial production and technological development. More policy directives and affirmative action policies are required so that the Dalit-Adivasi class emerges as the crucial influencers in the global economy.

The possibility of a democratisation

the subaltern social groups into the rightwing platform to curtail the BJP's aggressive communal rhetoric and force the state to deal with the concerns of social justice. The development has the possibility to make the right-wing platform conducive to the values of social reforms, to understand the ecological perspectives of Adivasis, and to democratise the higher strata of power. Such assurances and their effective implementation will make the BJP a substantive democratic party, responsible for the welfare and empowerment of India's subaltern masses.

Shared skies over divided streets: The story of Aligarh

n "City on Fire: A Boyhood in Aligarh," Zeyad Masroor Khan's debut book, the author delves into the complexities of communal violence and the search for identity in a divided world. India Debunks IMF's Assessment **About Excessive Currency Intervention**



NEW DELHI: India has hit back at the International Monetary Fund (IMF) for saying the Reserve Bank of India's (RBI) intervention in the foreign-exchange market was excessive.

It indicated that the country was trying to influence the level of the rupee. The Washington-based lender said the currency moved within a very narrow range from December 2022 to October 2023, suggesting the central bank's intervention "likely exceeded levels necessary to address disorderly market conditions."

As a result, the IMF re-

classified India's foreignexchange regime to a "stabilized arrangement" from a "floating" system, it said in its annual Article IV country report released on Monday. India "strongly disagreed" with the assessment, calling it "unjustified," the IMF said. The Reserve Bank of India stated that the period was restricted to a short-term, and that the IMF's assessment would fail over a two to five-year horizon, the fund said. "The RBI strongly believes that such a view is incorrect as, in their view, it uses data selectively," the IMF said in its report.

Sovereign Credit Ratings Inconsistent, Not Transparent: CEA

NEW DELHI: The Chief Economic Adviser (CEA) of India has criticised the sovereign credit rating methodologies employed by leading global agencies such as Fitch, Moody>s, and Standard & Poor>s, citing their opacity and failure to accurately represent the underlying economic fundamentals of the Indian economy, in a report released on Thursday The report strongly advocates

for a rating upgrade, highlighting the inconsistency in India>s sovereign ratings, which have remained static at BBB- over the past 15 years.

Despite ascending from the 12th largest global economy in 2008 to the 5th largest in 2023, with the second-highest growth rate among comparator economies during this period, the nation's ratings have not reflected this economic evolution, the CEA's office noted.

The BBB- rating by Fitch and Standard & Poor>s is considered the lowest investment grade, with an equivalent rating of Baa3 by Moody>s.

RBI Broadens Card-On-File Tokenization Scope for Digital Payment Security



NEW DELHI: In an effort to enhance the security and reliability of digital payments, the Reserve Bank of India has now enabled card-on-file tokenisation (CoFT) through card issuing banks and institutions. Previously confined to merchant applications or websites, individuals now have the option to tokenize their cards using internet and mobile banking services.

To mitigate the risk of data breaches and leaks, RBI implemented the rule of tokenisation in September 2021. Under this regulation, rather than storing actual card details, a unique token, specially generated for each transaction, is securely saved with the merchant.

Earlier, it was a common practice for merchants to retain card information, and in certain instances, users were frequently required to save their card details on the merchants app or webpage prior to finalizing a transaction. However, this practice of indiscriminately storing such sensitive information posed risk to the security of users> financial data.

"It has been decided to enable card-on-file tokenisation directly through card-issuing banks/institutions also. This will provide cardholders with an additional choice to tokenise their cards for multiple merchant sites through a single process," stated the RBI circular. The circular further stated that the generation of Card-on-File Tokenization (CoFT) must be carried out solely upon explicit customer consent and with the validation of an Additional Factor of Authentication (AFA). Additionally, the card issuer is required to furnish a comprehensive list of merchants for whom it is equipped to offer tokenization services.

Over 32,000 MSMEs Shut Shop Across India In 3 Years, Maharashtra Tops List

NEW DELHI: Indian Micro, Small, and Medium Enterprises (MSMEs) have faced closures of nearly 32,385 units in the last three and a half years, disclosed Union Minister of State for MSMEs, Bhanu Pratap Singh Verma, in

the Rajya Sabha on Monday. These MSMEs have cancelled their registrations on the Udyam portal, marking the end of their operations between July 1, 2020, and December 11, 2023, reported the Union Minister.

The most notable closures occurred in Maharashtra, where 3,066 MSMEs shut down operations this year alone, closely followed by

Stating the right of countries to appeal, India called for early restoration of the non-functional appellate body of WTO so that the panel's errors can

Hong Kong plummets to 46th spot in latest Human Freedom ranking as China continues to violate "one country, two systems" pact



TORONTO: As a result of increasing restrictions on liberties in Hong Kong—once among the freest places on earth—it now ranks 46th in the latest Human Freedom In*dex* report, released today by Canada's Fraser Institute and the U.S.-based Cato Institute.

As recently as 2010, Hong Kong was the 3rd freest jurisdiction on earth. Mainland China has always been less free than the territory and this year, China ranks 149th out of 165 jurisdictions.

"Freedom has suffered a precipitous decline in Hong Kong, but its tragic descent into oppression provides important lessons about the value of freedom," said Fred McMahon, resident fellow at the Fraser Institute and coauthor of this year's report.

The index measures personal freedom—the rule of law, safety and security, identity and relationships (i.e. the freedom to choose your relationship partner), freedom of movement, speech, assembly and religion—alongside economic freedom, the ability of individuals to make their own economic decisions.

This year's report ranks 165 jurisdictions around the world. It finds that from 2019 to 2021 (the latest year of available data), 89.8 per cent of the world's population experienced a decline in freedom.

In Hong Kong, the areas that show the most pronounced declines in this year's report are: The rule of law, freedom of expression,

and assembly.
