President appoints Narendra Modi as PM-designate; oath on Sunday evening



NEW DELHI: Narendra Modi will take oath as the prime minister for a third consecutive term on Sunday evening as President Droupadi Murmu has invited him to form the government.

 $Murmu\ appointed\ Modi\ as$ the prime minister-designate on Friday after BJP chief JP Nadda handed her a letter on Modi's election as the leader of the BJP Parliamentary Party and NDA leaders submitted their letters of support.

The BJP won 240 seats in the just-concluded Lok Sabha polls, falling short of the halfway mark in the 543-member House, but the National Democratic Alliance (NDA) together won 293 seats, which is a comfortable majority.

"The President, having satisfied herself on the basis of the various letters of support received, that the BJP-led NDA alliance, which is also the largest pre-election alliance, is in a position to command majority support of the newly-constituted 18th Lok

Sabha and to form a stable government, appointed Shri Narendra Modi as the Prime Minister of India, exercising powers vested in her under Article 75(1) of the Constitution of India," according to a communique from the Rashtrapati Bhawan.

The President will administer the oath of office and secrecy to the prime minister and other members of the Union Council of Ministers at 7.15 pm on Sunday at the Rashtrapati Bhavan, the communique said.

Murmu handed over the letter of appointment to Modi, who called on her at the Rashtrapati Bhavan here on Friday

"Hon'ble President Smt Droupadi Murmu offered curd to leader of NDA and PM designate Shri @narendramodi whilst inviting him to form the BJP-led NDA government at the Centre," the saffron party said in a post on X along with a photo of Murmu and Modi.

Modi said the Rashtrapati Bhavan will work out the details of the oath-taking ceremony on Sunday, by when he would hand over the list of the Council of Ministers to the president.

"Tĥis 18th Lok Sabha is an important milestone towards fulfilling those dreams when the country will celebrate 100 years of independence in 2047," he said.

RBI raises GDP growth forecast for 2024-25 to 7.2 pc, sees CPI inflation at 4.5 pc



NEWDELHI: The RBI has raised India's GDP growth forecast from 7 per cent to 7.2 per cent for the current financial year (2024-25), as it expects the economy to continue on a high growth trajectory. However, it has decided to stick to its CPI inflation forecast for 4.5 per cent for the year.

RBI Governor Shaktikanta Das said the GDP growth in the first quarter of 2024-25 is likely to be at 7.3 per cent, 7.2 per cent in Q2, 7.3 per cent in Q3, and 7.2 per cent in the last quarter. The pattern of world crisis continues, but India is headed for a sustained high growth based on its demographics, productivity and the right government policies in place. However, at the same time, we need to be vigilant in the backdrop of an unsettled global environment,

Das said. The RBI left the key reporate unchanged at 6.5 per cent in its monetary policy review on Friday as it continues to maintain a balance between economic growth and keeping inflation

Gandhi demanded an inquiry by the Joint Parliamentary Committee (JPC) to probe the role of the Prime Minister, the Home Minister and the Finance Minister.

Addressing a press conference at the AICC headquarters here today, Gandhi pointed out that Prime Minister Narendra Modi, the union Home Minister Amit Shah and the union Finance Minister Nirmala Sitharaman all advised people to buy stocks

before June 4, the date of results. He alleged that fake Exit and suffered huge losses.

Polls were pedalled on June 1 at the end of the last phase of elections, which led to massive buying on June 3, a day before the actual counting. When the actual results were way off the mark from the Exit Poll claims. the market crashed leading to loss of Rs 30 lakh crores to the retail investors, he pointed out.

The former Congress president observed that all this was leliberately and wilfully planned and executed. He claimed that the BJP knew that its seats were not going to be more than 220 from its internal survey and the feedback from the intelligence agencies. He said, despite that, the Exit Polls were made to show that the BJP was winning a large number of seats.

Besides, he pointed out, the interviews were carried out by the channels owned by Adani. He asked, why did the PM and the HM need to give investment advice which people are bound to take seriously, which they did,

AAP's 'mission 13' collapses as vote share from 42% in 2022 drops to 16% in Punjab

The ruling party's vote share has also gone down in Punjab and has witnessed a drop from 42% in the 2022 polls to 16% in present Lok Sabha polls. The election results on Tuesday from the 13 Lok Sabha constituencies in the state are a severe shock for the Aam Aadmi Party (AAP) in Punjab. Punjab vote share results are less than that of the Congress specified as around 26%, which won seven Lok Sabha seats in the state. These parliamentary polls have exhibited a critical mid-term test of the popularity of the AAP in Punjab, which had secured a historic mandate of 92 seats in the 117 state assemblies about two years ago. However, in this election, the AAP won just three: Sangrur, Hoshiarpur and Anandpur Sahib seats, though this is an improvement

CISF constable who 'slapped & abused' Kangana at Chandigarh airport suspended



CHANDIGARH: The CISF constable who "slapped and abused" actress-turned-newly-elected MP from Mandi, Himachal Pradesh, Kangana Ranaut, at the Chandigarh airport on Thursday has taken to the CISF Commandant Office for questioning after being placed under suspension.

The constable, Kulvinder Kaur, who has been on duty at the airport for the past twoand-a-half years, in fact, was seen on television channels after the incident, stating that she was upset because of the kind of statements made by

agitation.

"My mother was also among the protesters when she (Kangana) made these remarks, Kaur could be heard saying.

"She gave a statement that the farmers are sitting there for Rs 100. Will she go and sit there? My mother was sitting there and protesting when she gave this statement, "Kaur added.

It is learnt the constable was also unhappy because Kangana referred to the protesting farmers as 'Khalistanis'.

The incident took place when $\,$ Kangana was travelling to New

Kangana also posted a video on X to confirm eyewitness reports that she had been "slapped and abused" by Kaur when she was on her way to board a flight from Chandigarh to New Delhi.

Police said that both the arrested accused were in touch with the Pakistani based smugglers and were managing to smuggle drugs from Pakistan and send them money through the Hawala





Supreme Court monitored probe into the irregularities in the National Eligibility cum Entrance Test (NEET) conducted by the National Testing Authority. Addressing a press confer-

ence, senior Congress leader the test with all of them scoring and in-charge of the National Students' Union of India Kanhaiya Kumar and NSUI president Varun Choudhary stressed upon the government to address the concerns and complaints of the aspirants.

Kanhaiya Kumar said, now irregularities have become the routine in these exams. He said, it is a vicious cycle that first the exams are not being conducted on time and once exams are held, irregularities are reported which eventually leads to the cancellation of the exams, thus wasting precious time of the students besides pushing them into frustration and state of helplessness.

The senior Congress leader rejected the clarification issued by the NTA, asking how it was possible that 67 students topped

100 percent marks. Besides, he added, out of these 67 toppers, 12 students had taken the NEET exam sitting in the same centre.

He clarified that he did not of the students, but the ability of the examining authority, the NTA, had come under questions.

Kumar pointed out that the NEET result was scheduled to be declared on June 14 and it was surprisingly advanced to June 4, when the whole country was busy watching the General Election results. He asked what was the urgency in advancing the results by ten days and announcing these on the same day when the votes were being counted.

Expressing serious concern over the credibility of the examinations in the country, he

expressed strong apprehensions that the day may not be far when even the UPSC examinations come under question. He asked the government to

take the matter seriously and fix raise any questions on the ability the responsibility by ordering a SC-monitored probe into the allegations of irregularities. BJP sweeps both LS and assly in Odisha

Bhubaneswar

Chief minister and Biju Janata Dal (BJD) president Naveen Patnaik is set to bow out of power after holding the reins of the state for 24 years with BJP sweeping both Lok Sabha and assembly polls in the state.

At the time of reporting the saffron party had won 32 seats in the 147-strong assembly and was leading on 47, thus heading for a clear majority. In contrast, the BJD had won 27 and was leading on 23 with chief minister trailing in Kantabanji, the second seat he is contesting from besides his traditional seat of Hinjili. The Congress improved its performance of 2019 and won six seats and established a lead on nine other seats as counting reached the final stages.

The BJD suffered a humiliating defeat in the Lok Sabha with the party ahead on the sole seat of Jajpur which has been its stronghold since 1999. While Congress seems likely to retain the Koraput seat, BJP candidates had established firm leads on all other 19 Lok Sabha seats



Dharmendra Pradhan had won the Sambalpur seat with only an official announcement awaited. The party was likely to win all the 19 seats.

Some of the BJD heavyweights who fell by the wayside included Pranab Prakash Das aka Bobby who lost to Dharmendra Pradhan from Sambalpur Lok Sabha constituency. In the state assembly minister Ashok Panda lost from Bhubaneswar Ekamra constituency. Reports said that senior minister Atanu Sabyasachi Nayak had also lost from Mahakalpada. Former union minister and BJP candidate from Rourkela Dilip

Ray also lost. The saffron sweep in the Lok Sabha constituencies was not



the party had concentrated its entire energy on increasing its Lok Sabha tally in a bid to compensate the losses that it anticipated in some of the heartland states. It was even supposed to increase its 2019 assembly tally of 23 but an outright victory for the party has boosted its morale.

The credit for BJP's spectacular performance in the state should go to Prime Minister Narendra Modi's aggressive campaigning in the state. He took a gamble by targeting chief minister Naveen Patnaik and also his Man Friday bureaucrat-turned-politician VK Pandian. The high voltage campaign often turned acrimonious with Prime Minister not shying away from making per-

sonal attacks against Patnaik who was forced to respond. Pandian, too, trained his guns at the Prime Minister and his party colleague if only to defend his boss. It seems ironical that the

elections began with an attempt at reviving the old al-liance between BJP and BJD which collapsed in 2009 after serving both sides well for nearly 11 years. However, efforts in this direction failed despite prolonged parleys between the top leaders of the two parties and their in-house discussions. Leaders on both sides finally gave up as cadres, unwilling to accept a patch-up bid, showed signs of rebellion.

However, the failed bid to revive the alliance did more damage to BJD than BJP. The Prime Minister also kept issues of Odia pride and state's underdevelopment at the centre of his campaign in the state. To this he added the alleged anxiety over 77-year-old chief minister's failing health and promised to constitute a committee to look into the issue if BJP came to power in the state. Pandian was accused of practically taking Patnaik hostage and deliberately suppressing

2024 poll results offer lessons to BJP and Congress

he outcome of India's 18th

general election reaffirms the principle that democracy centers around the will of the people. The verdict on June 4 saw the Bharatiya Janata Party (BJP) fall short of an absolute majority, a stark contrast to its campaign assertions. The National Democratic Alliance (NDA), however, secured a majority with over 290 seats. The BJP's tally of 240 seats marks a significant drop from its 2019 strength of 303, underscoring a shift in the political landscape. This election outcome sends a clear message: the electorate desires a more conciliatory and inclusive BJP, reflecting the limitations of communal polarization as a viable electoral strategy. The BJP is now held accountable to be more constructive, embracing the resurgence of coalition politics after a decade of dominance. The Congress, with nearly double its 2019 seats at 99, has reestablished itself as a key player in Indian politics. Yet, it must respect the pre-poll alliances and avoid post-poll coalition attempts. The Congressled INDIA coalition fell short of a majority, demanding steadfast adherence to the prepoll mandate. The BJP's overreliance on Prime Minister Narendra Modi's charisma exposed organizational weaknesses, and anti-incumbency sentiments further eroded its standing. Despite this, the BJP's ideological roots in its strongholds enabled it to retain significant influence, even winning a seat in Kerala and making inroads in Odisha. The Congress's focus on livelihood issues and equity resonated in direct contests with the BJP in Karnataka and Rajasthan, highlighting the need for both parties to learn from this verdict. The election also emphasized India's diversity and the importance of genuine coalitions over transactional alliances. India's vibrant democracy has once again showcased its resilience and the critical role of voter expectations. The new government must rise to this challenge, respecting the electorate's diverse aspirations.

Economic justice needs spotlight



e results of the 2024 Lok Sabha elections have come as a shock to those who had mistakenly believed in the problematic exit polls, which continued the narrative so assiduously cultivated by the previous Modi government. Many pundits who had confidently justified those false predictions have already jumped to explain the actual results. One main explanation is that the INDIA alliance emphasised social justice and the caste census, stitched up more astute coalitions, and made sharper candidate choices in terms of caste.

There is no doubt that the recognition of the need for social justice as well as the fears about the survival of the Constitution were significant factors. Local factors in different States also would have played a role. But whoever forms the next government must recognise a clear message from the electorate: the importance of economic issues. The major crises of unemployment and persisting low wages, inadequate livelihoods from self-employment, and rising prices of essentials were all effectively ignored by the Modi government, both in its policy actions and in the electoral campaign. Yet these bread-and-butter issues continue to define the lives of the majority of people in the country.

This is where the promises made by the Opposition INDIA alliance, especially the Congress, may well have been significant, especially in parts of the Hindi heartland such as Uttar Pradesh. Unlike the Modi regime, and sections of the mainstream media that faithfully reproduced the BJP's voice, these parties focused on issues of livelihood and employment, along with social justice. Their promises undoubtedly found resonance with much of the



A fundamental transformation

The focus on justice for youth, women, farmers, and workers, as well as dignity through social justice, which was strongly highlighted in the Congress manifesto for example, necessarily implies a major shift in economic policy. In fact, what is required is nothing short of a fundamental transformation. The most important shift is to move back to a framework of human rights, especially social and economic rights, rather than seeing public goods and services delivery as "gifts" from the state or a supreme leader.

This requires two immediate changes in the economic policy framework. The first is ensuring basic social and economic rights for everyone by expanding the right to work (through a better funded and more flexible MGNREGA as well as the introduction of an urban employment guarantee scheme); the right to food, which is still inadequate and denied to at least 100 million Indians; the right to education, based on public delivery rather than expensive and exclusionary private education;

security, especially through universal pensions provided at half the minimum wage to the elderly and those unable to work for other reasons; and the right to health, once again through public de-

The second is to create jobs to address the frustrated aspirations of hundreds of millions of young people.

This must become the primary economic goal. This requires expansion of public employment. First, vacancies need to be filled and all public workers, including "scheme" workers, need to be regularised The needs of micro, small and medium enterprises, which have been truly battered by the policy mistakes of the past decade, need to be delivered through a comprehensive package covering credit, access to new technologies and training, infrastructure provision, and marketing assistance. Farming continues to be in crisis. The valid demands of the farmers' movement need to be taken on board, ideally after a special session of Parliament devoted to discussing them in detail. Special attention needs to be paid to the ongoing impact of climate change and higher temperatures.

Much has been made of the "new welfarism" of the Modi government. But it is more accurately described as "the new branding around welfarism", with not much change in level or content. Successive

been oriented to the provision of welfare schemes, which are obviously necessary given continuing poverty and poor human development indicators across much of the country. The Modi government advertised its interventions as completely new when they are, in fact, merely continuations or expansions of old schemes; or as gifts from the Prime Minister. Instead, they need to be advertised as ways of fulfilling citizens' rights. For example, the free food ration has been touted as a major gift to around 800 million people. But in effect, the food being offered under the Public Distribution System under the National Food Security Act brought in by the previous United Progressive Alliance government was already heavily subsidised - at only Rs 2 per kg of wheat and Rs 3 per kg of rice. So, this was not such a big difference. We need a shift from promises of welfare as "gifts" to a reaffirmation of the discourse on rights.

Revival of federalism

An important shift that is likely to result from this election is the revival of genuine federalism, away from the undemocratic centralisation evident over the past decade. State governments are responsible for most of the public service delivery that affects ordinary people: it is critical for them to be able to provide these without interference, control and partisanship from the Centre.

Refine strategies to manage health-care costs



s we navigate the dynamic landscape of Indian health care, cost considerations are increasingly influencing every aspect of service delivery and patient care. With rising health disparities and uneven access to medical services, the need for equitable and sustainable health-care policies has never been more urgent than now. Ongoing discussions about setting rates for medical services are not just bureaucratic exercises. They fundamentally shape how we perceive, access, and deliver health care across India. In this globalised era, we see a variety of responses to similar challenges worldwide, shaped by differing cultural, economic, and systemic factors. By learning from these international examples, we can refine our strategies to manage health-care costs more effectively.

Private hospitals are not only centres of Take the examples of the Joint Commission International (JCI) and NABH (National Accreditation Board for Hospitals)-accredited big hospital groups, which have embraced cutting-edge technologies to significantly enhance patient outcomes, especially in complex procedures. These institutions invest heavily in top-tier infrastructure and advanced technologies, enabling them to seamlessly integrate telemedicine and remote care, thus broadening access and building patient trust.

As the Supreme Court deliberates on standardising medical procedure rates across government and private sectors, we must consider the allure of affordability. Yet, imposing one-size-fits-all price caps could severely undermine health-care quality. A Health Care Management Review study shows that hospitals under financial pressure from price caps report a 15% increase in patient dissatisfaction. Moreover, such caps



could drastically slow the development of new treatments and technologies, notably in fields such as cancer research and robotic surgery, where significant investment is solution, where payments reflect health outcomes rather than service volume?

The broader economic implications of health-care pricing policies reach far beyond the health-care sector itself. Properly implemented rate standardisation can alleviate health-care disparities, yet we must be cautious not to destabilise providers' economic health. Economists recommend dynamic pricing models that adjust based on medical complexity and the financial status of patients, offering a fair solution. For instance, Thailand's tiered pricing system, which considers patient-income levels and medical necessity, successfully balances cost and care and could serve as a model for India's diverse economic landscape.

Legal and regulatory challenges

Managing health-care costs effectively demands legislative reform. Tailoring approaches to accommodate local demographic

and economic conditions can support rate standardisation and high-quality care. States such as Rajasthan and Tamil Nadu have already pointed out gaps in rate fixation provisions, advocating for robust legal frameworks to navigate these issues successfully.

Technology is revolutionising health care, making diagnostics faster and more accurate with artificial intelligence and improving care coordination through electronic health records. For example, telemedicine initiatives in Karnataka have slashed hospital

visits by 40%, demonstrating how technology not only makes medical care more accessible, especially in remote areas, but also more cost-effective. This integraes pressure on health-care facili ties while delivering timely care directly to

Moreover, innovations such as mobile health apps and wearable devices are crucial in managing chronic conditions outside hospitals, significantly cutting costs and enhancing patient outcomes. As we push these technologies forward, ensuring that they reach all population segments is key. Investing in infrastructure for broader Internet access and improving digital literacy will empower more people to benefit from these advancements, setting the stage for India to lead globally in health-care innovation.

Recent surveys with health-care professionals across India show a consensus on the need for flexible pricing strategies that mirror the complexities of medical procedures and patient-care requirements. Engaging all stakeholders, including private health-care providers, is essential in order to grasp the nuanced dynamics and craft

effective, sustainable policies.

Role of data in shaping policies

In today's big data era, health-care policy decisions should increasingly rely on datadriven insights. Data analytics can shed light on patient outcomes, treatment efficacy, and cost-efficiency, informing more nuanced rate-setting frameworks. Moreover, predictive analytics could foresee the longterm impacts of rate fixation on health-care innovations, helping policymakers adjust regulations to encourage innovation and accessibility.

Balancing access, innovation, and affordability in health care is delicate but imperative. We recommend implementing pilot projects in select districts to gauge the impact of rate caps on health-care quality and innovation, allocating government subsidies private hospitals, and establishing publicprivate partnerships to integrate cutting-edge technologies in public hospitals, ensuring widespread access to advanced health-care solutions.

As India aspires to be a global health-care leader, fostering an environment conducive to innovation while ensuring equitable access to quality health care is crucial. It is time to prioritise the well-being of every individual, as echoed by Dr. Vinod K. Paul, Member, NITI Aayog. "Affordable healthcare is not just a necessity but a priority for our nation, and we are committed to innovating and leveraging technology to bring down healthcare costs for every citizen.'

Design deception: How tech firms control your choices

magine planning a holiday for your family. You book affordable plane tickets, arrive at the airport early, check in your luggage, and board the flight. Then you realize your toddler is seated in front of the toilet, you're ten rows away, and your family is scattered throughout the flight. When you complain, the airline says you should have paid extra to ensure your seats were together.

You recall seeing that option on the website but skipped it due to the high cost. Your frustration comes from a deceptive user interface known as a "dark pattern."

User experience (UX) designer Harry Brignull coined the term 'dark pattern' in 2010. It's used today to describe unethical practices where companies manipulate their user interfaces. These designs trick users into spending more money, making unfavorable decisions, or giving up on actions that don't benefit the company.

Deceptive Patterns: Exposing the Tricks Tech Companies Use to Control You by Harry Brignull is a guide to recognizing and tackling these deceptive practices. It's for everyone, from casual internet users to antitrust lawyers. Brignull has spent over a decade naming and shaming companies that use these tricky design practices, based on complaints and screenshots shared with him.

Some common offenders include Google, Microsoft, Meta, Adobe, and Quora. In India, IndiGo and Amazon India have been named.

Researching and writing this self-published 2023 book was a monumental task, considering the internet's evolution and the increasing use of automated tools by businesses. Brignull skillfully covers Big Tech's misdemeanors and regulations against deceptive patterns, using solid examples and case studies.

Brignull explains many common deceptive patterns you might have encountered. "Confirm Shaming" forces you to click negative statements like 'I don't want to be healthy' to avoid subscribing to newsletters. Urgency messages like "Only 1 left in stock!" use your own urgency against you. "Visual Interference" makes it hard to turn off trackers and cookies. Fake testimonials feature praise from faceless users with generic names.

The "Hidden Costs" pattern lures you with a low price, only to add extra fees at the last minute, pressuring you to complete the

gnull writes. "It's about tracking, testing, psychology, behavioral economics, and statistics. It's all about achieving business goals and making money.

Brignull shows how these patterns exploit people with busy lives or vulnerable users like children or seniors. He also exposes countdown timers on e-commerce sites, which often reset and start again without affecting the product price.

Brignull explains how deceptive practices harm the marketplace, making it harder for honest businesses to build a customer base. Users get trapped in toxic ecosystems where they struggle to delete accounts, end subscriptions, or recover lost payments.

While rich in information, Deceptive Patterns can be uneven and sometimes hard to finish. Brignull's narrative shifts between conversational and informative styles, which can disrupt the flow. The sections on legislation are dense and packed with summaries of various legal articles, which might feel overwhelming.

However, Brignull's effort to make U.S. and EU digital regulations accessible to global readers is commendable. He encourages readers to draw parallels with their own countries' laws and start conversations about deceptive patterns.

Despite the technical subject matter, Brignull writes with compassion. He urges action against deceptive patterns without being alarmist. He considers the impact on non-native English speakers, low-income users, and people with disabilities. He also advocates for using the term 'deceptive patterns' over 'dark patterns' to be more inclusive.

related risks and opportunities.

Goals (MDGs), i.e., eight international development goals which were to be achieved by 2015, as established guiding principles at the Millennium Summit hosted (in New York) in the year 2000 by the United Nations. Certain SDGs have direct implications for pharmaceutical sector which include 'Good Health and Well-being', 'Quality Education', 'Gender Equality', 'Clean Water and Sanitation ', 'Affordable and Clean Energy', 'Decent Work and Economic Growth', 'Reduced Inequalities', 'Responsible Consumption and Production', 'Climate Action', and 'Partnerships for the goals'.

The Securities and Exchange Board of India (SEBI) as the regulator for equity markets took proactive steps to enhance ESG disclosures within the corporate sector, and introduced a novel reporting framework - the Business Responsibility and Sustainability Report (BRSR). In the fiscal year 2021-22, it was implemented on a voluntary basis. From 2022-23 onwards, it was made mandatory by the SEBI for the top 1,000 listed entities (based on market capitalization). The BRSR fosters transparency and accountability among listed companies.

All top listed pharmaceutical companies provided the Business Responsibility and Sustainability Report (BRSR), as it is mandatory for the top 1,000 listed companies. Except the Millennium Development Mankind Pharma, other top

nine pharmaceutical companies explicitly mentioned the United Nations' Sustainable Development Goals (SDG) as ESG framework applied. Eight pharmaceutical companies except Divi's Labs and Mankind Pharma, followed the Global Reporting Initiative (GRI) framework. Fourth most popular ESG framework for pharmaceutical companies is Sustainability Accounting Standards Board (SASB) as it has been followed by seven pharmaceutical companies except Cipla, Divi's Labs, and Mankind Pharma. Fifth most popular framework followed by top ten pharmaceutical companies in India is Carbon Disclosure Project (CDP) which is followed by Sun Pharma, Dr. Reddy's Labs, Divi's Labs, Lupin and Abbott India.

As observed from annual reports for the year 2022-23, these top pharmaceutical companies are providing the Business Responsibility and Sustainability Report (BRSR). Over and above the mandatory requirement, these companies are also following globally accepted ESG frameworks such as UN SDG, GRI, SASB and CDP. Reporting by these pharmaceutical companies on these standards in their Annual Reports is reflected in the ranking of these companies by the S&P Global ESG Score that has been given in the Table 2.

In Indian context, the Securities and Exchange Board of India (SEBI) amended existing Securities and Exchange Board of India (Credit Rating Agencies) Regulations, 1999 in July 2023. Through these amendments, it introduced Chapter IV A on ESG Rating Providers (ERPs). It defined 'ESG Ratings' as the rating products that are marketed as opinions about an issuer or a security, regarding the ESG profile or characteristics or exposure to ESG risk, governance risk, social risk, climatic or environmental risks, or impact on society, climate and the environment, that are issued using a defined ranking system of rating categories, whether or not these are explicitly labelled as "ESG ratings"

Credit rating agencies in India recognized the potential of ESG ratings, and launched ESG rating services. Prominent rating agency - ICRA Limited had announced in September 2023 about its application in the name of Pragati Development Consulting Services Limited (PDSCL), and statutory approvals were sought for the change in the name to ICRA ESG Ratings Limited. With more ESG Rating Providers catering to requirements of companies from different sectors, ESG reporting by pharmaceutical companies is likely to improve in future. Complexity of the value chain in case of a pharmaceutical company is likely to put intense pressure on Indian pharmaceutical companies. In near future, it is going to be tough for those pharmaceutical companies from India which operate in Europe and the United States. In the EU, non-EU companies doing business there, have to make disclosures under the Corporate Sustainability Reporting Directive (CSRD) as the European Commission adopted the CSRD in November 2022. In Indian context too, the SEBI has become proactive through introduction of ESG Reporting through BRSR and approvals to ESG Rating Providers.

SBI Expects Reserve Bank Rate Cut in Q3 FY25

of India (SBI), in a research report published ahead of the Reserve Bank of India's (RBI) June 5-7 monetary policy committee meeting, stated that the central bank is expected to implement its first rate cut in the third quarter of the current fiscal year 2024-25. However, the report noted that any potential rate reduction cycle is likely to be shallow, with measures focused on augmenting liquidity.

According to the SBI analysis, while emerging economy central banks often follow the lead of advanced economy counterparts in rate actions, India represents an exception to this pattern.

The report highlighted that the RBI's stance in the upcoming policy meeting should continue to prioritize the withdrawal of accommodative measures. This projection comes amid

The RBI operates under a statutory mandate to maintain consumer price index (CPI) inflation at 4 per cent.

The decisions were taken by a majority vote of 5:1 within the six-member MPC, chaired by Governor Das.

NEW DELHI: The Reserve Bank of India (RBI) is increasing oversight on asset reconstruction companies (ARCs) that purchase bad loans fr0m banks and non-bank financial

The central bank has mandated that ARCs classify borrowers by risk profile and regularly verify KYC (know your customer) details after acquiring non-performing assets.

This move aims to enhance fraud detection and anti-money laundering measures within the ARC industry, subjecting these firms to the same rigorous standards applied to banks. ARCs will now be required

to follow the central bank's 2016 KYC guidelines, which mandate obtaining customer proof of identity and address, and periodically updating this information based on risk categorisation. According to ARC industry executives, the RBI has instructed these firms to verify KYC data even for bad loans acquired fr0m lenders that have existing KYC details on file.

Auditors have emphasised that merely purchasing KYCcompliant assets is insufficient,

NEW YORK: A group of lenders on Wednesday petitioned against new entities, tied to embattled edtech company Byju's US subsidiary, into bankruptcy in a US court, alleging that these entities are not paying their debts.

The group of lenders, which gave Byju's Alpha \$1.4 billion term-loan, petitioned against Neuron Fuel Inc., Epic! Creations Inc. and Tangible Play Inc. to Chapter 11 of the US Bankruptcy Code to initiate involuntary proceedings against them, in the Delaware court.

The lenders said in a statement that since Byju's began to default (on \$1.2 billion of debt) on its term-loan obligations, "we have made every effort possible to work productively and col-



laboratively to help Byju's cure its multiple defaults".

"However, it is clear that Byju's management has no intention or ability to honour its obligations under the Term Loans. Indeed, BYJU's founders, who also serve as the three directors of the overall enterprise - Byju Raveendran, Riju Ravindran, and Divya Gokulnath - unlawfully diverted \$533 million in loan proceeds, the whereabouts of which are still

unknown, "the creditors al-

The edtech company had earlier claimed that no funds have been siphoned off and around \$533 million are "currently in a 100 per cent non-US subsidiary of the company".

The lenders further said that as a result of Byju's failed leadership and mismanagement, significant harm has been done to the company's businesses and the value of the company's assets.

"Shareholders and lenders to

the company have seen the value of their investment deteriorate, employees and vendors have not been paid in a timely manner, and customers have suffered, the lenders said.

Once valued at \$22 billion, the edtech company's valuation has plummeted around 95 per cent after investors cut their stakes in several rounds.

The group of lenders said with their action, "Epic!, Neuron Fuel, and Tangible Play will benefit from much-needed oversight while a plan is developed to maximise the value of these assets for the benefit of all stakeholders.

Joe Biden signs executive order to curb unlawful border crossings by immigrants

WASHINGTON: US President Joe Biden has signed an executive order that would immediately turn down requests for entry into the country by asylum-seekers crossing the southern border illegally, in the event that officials deem the border is overwhelmed.

The long-awaited measure. which Biden has been contemplating for months, would kick in once the seven-day average for illegal crossings between ports of entry along the US-Mexico border hits 2,500 per day, effectively shutting down the border, Xinhua news agency reported, citing senior administration officials.

Given that the daily encounters are already above the threshold now, the order could take effect right after being signed, empowering border officers to repatriate migrants within "days, if not hours, "the officials told reporters during

Prior to Tuesday's order, an illegal immigrant seeking asylum in the US would typically be allowed to temporarily enter the country, where the individual will wait for a court appearance to present a compelling case for the request.

Under the new guidance, the border will reopen to those seeking asylum in the US two weeks after the daily crossings stay at or below 1,500 for seven consecutive days.

Pakistani PM Sharif in Beijing for talks with President Xi to seek more investments, elevate ties



BEIJING: Visiting Pakistani Prime Minister Shehbaz Sharif has reached Beijing for talks with Chinese President Xi Jinping and other leaders to elevate all-weather bilateral ties and prospects of more aid and investments to bail out his cash-strapped country from the current economic crisis.

Sharif, on a five-day official visit to China since June 4, toured the southern high-tech city of Shenzhen on Wednesday and addressed the investors meeting. During his stay here, Sharif will meet Xi, Premier Li Qiang and other leaders, Pakistan's state-run APP news agency reported. He will also attend a Pakistan-China Friendship and Business event and have meetings with the CEOs of leading Chinese companies working on the China-Pakistan Economic Corridor (CPEC) projects.

Several MoUs between the two countries on cooperation in various fields are likely to be signed, the report said. Cashstrapped Pakistan's economy is facing severe headwinds, and it has formally requested the International Monetary Fund (IMF) for the next bailout package between USD 6 billion and USD 8 billion with the possibility of augmentation through climate financing. It added that the initiative is rooted in shared values, common goals and a shared vision for inclusive development.

The JTFI was formed to foster mutual growth and prosperity by facilitating binomic engagement between India and Qatar, two nations with historically amicable ties.

Thursday's discussions pave the way for deeper coordination on priority areas identified by both sides. Officials did not disclose specific investment targets or deals discussed during the meeting. However, India is keen to attract greater Qatari investment in its infrastructure projects, while Qatar remains a key energy partner supplying liquefied natural gas to meet India>s growing energy needs.

Biden apologises to Ukraine's Zelenskyy for months-long holdup to weapons that let Russia make gains



on Friday for the first time publicly apologised to Ukrainian President Volodymyr Zelenskyy for a months-long holdup in American military assistance that let Russia make gains on the battlefield.

Speaking in Paris, where they both attended ceremonies marking the 80th anniversary of the D-Day landings, Biden told Zelenskyy that, he apologised to the Ukrainian people for the weeks of not knowing if more assistance would come while Congress waited six months before sending Biden a USD 61 billion military aid package for Ukraine.

Still, Biden insisted that the American people were standing by Ukraine for the long-haul. "We're still in. Completely. Thoroughly," he said.

Italy marks Republic Day with calls for unity



ROME: Italy celebrated the 78th anniversary of its founding as a republic, with President Sergio Mattarella calling for unity in Italy and across In his remarks, Mattarella

said on Sunday that the creation of the Italian Republic created "an Italy open to Eu- ni, the Presidents of the Senate rope" and he called for unity in Italy and across Europe.

He also cited the importance of Italian multilateral cooperation, including within the UN and NATO, Xinhua news agency reported.

The Italian President's remarks come with an increase in violence across the world as well as increasing political $\,$ divisions between European Union states.

It also comes days before citizens in 27 European Union states, including Italy, go to the polls to select new members of the European Parliament.

Mattarella laid a wreath at the country's Tomb of the Unknown Soldier in Rome followed by a parade and the famed jet fly-over with smoke trailing the colours of the Italian flag.

Mattarella was joined by Prime Minister Giorgia Meloand the Chamber of Deputies, multiple government ministers, and Mayors from some 300 cities and towns. Dozens of members of the Italy-based diplomatic corps were also on hand.

In her remarks, Meloni said Italy should return to the "first idea of Europe" -- saying that it called for the autonomy of states, a reference to a balance between multi-state cooperation and national autonomy.

It also comes as Italy holds the rotating presidency of the G7 club of large industrialised countries.

HOUSTON: On the way to the International Space Station aboard Boeing's Starliner spacecraft, Indian-origin astronaut Sunita Williams and her colleague Butch Wilmore tested out a unique capability of the spacecraft on orbit manual piloting.

Williams flew to space for the third time on Wednesday along with Wilmore, scripting history as the first members aboard Boeing's Starliner spacecraft on a 25-hour flight to the International Space Station (ISS).

Williams, 58, is the pilot for the flight test while Wilmore, 61, is the commander of the

Although the spacecraft is usually autonomous, the crew used the hand controller to point and aim the spacecraft during about two hours of freeflight demonstrations.

During a far-field demo, they pointed Starliner's nose toward the Earth so that its communications antenna on the back of the Service Module was pointed at the Tracking and Data Relay satellites. They then moved the Starliner so that its solar array pointed at the sun to show they could charge the internal batteries if ever needed, Boeing said in a

statement.

Next, they swung Starliner

around and pointed the nose away from Earth to look at the stars. This was to show they could manually use the star trackers in the VESTA system to establish their attitude in space in case all three flight computers were to ever go out or be turned off at the

same time. Then, they manually sped Starliner up and then slowed it down, which slightly raised and then lowered their orbit. This was to show that the crew could manually break away from the space station orbit during rendezvous, if necessary.

Finally, the crew manually

pointed Starliner in the orientation needed for entry into the Earth's atmosphere, just in case they had to do that manually. During that manoeuvre, they again pointed the solar array at the sun to try a different method of confirming they could manually charge the batteries.

There is more manual piloting to come for this "pilot's spacecraft" with Wilmore and Williams on docking day, June 6. The Starliner spacecraft, dubbed Calypso, has been developed by Boeing, under a contract from NASA. It has run into several delays and glitches in its developmental

Moments before lift-off, Commander Wilmore called out to thank all those who had worked to make the mission possible. Alluding to past difficulties, he said: "When the going gets tough - and it often does - the tough get going, and you have." Starliner's pilot Suni Williams chimed in: "Go 'Calypso'! (the name of the capsule). Take us to space and back." This mission is a critical venture for manufacturer Boeing, which has been under pressure after a series of safety

incidents on its aeroplanes. Starliner, likewise, has encountered numerous techni-

cal issues that have delayed its planned crewed debut by

almost a decade. The most dramatic of these problems occurred on the cap-sule's first uncrewed test flight in 2019 when software errors forced the vehicle to abort its trip to the ISS. Nasa requested a second dummy run be conducted in 2022 to be sure the errors had been corrected.

Starliner was developed in response to NASA's request for commercial options to get its astronauts into space.

Following the retirement of the famous shuttles in 2011, the agency wanted to move away from owning and operating vehicles to an arrangement where it could simply purchase the service - just like a company might outsource its IT needs or payroll.

The new approach was designed to save NASA money it could then spend on ambitious plans to return people to the Moon.

The agency gave contracts to Boeing and SpaceX to help bring their capsules into service and then pay them for six operational missions. Whereas SpaceX was able to fly its crew flight test in 2020 and then complete six operational missions by March of this year, Boeing is still at the stage of the initial crew flight test.

Sopan Godkar (28), farmer/technocrat, turned out to be third-time lucky when he bagged a beautiful trophy and cash prize through his prizewinning oxen - Bullet (6 years) and Malhar (4years) - emerging winners in the "Bailgadi Shariat 2024" ox-carriage racing held in Kudal village of Maharashtra recently. The race is held during a "Zatra" (Fair) in different parts of Maharashtra, where sponsorship is provided by politicians, industrialists etc and prize amounts vary upto lakhs of rupees.

"We had oxen in our home where we kept them for farming and racing, which is a sport much patronised by all amidst much fun and frolic," Sopan said, adding that the winning ox is taken to a temple for puja and then home for sweet treats like "puran poli" "at my mother's hands." "While my Kolhapur partner owns Bullet who has won as many as 15 racing competitions, I bought Malhar in Kolhapur for Rs 85 -- at a time when ox-racing was banned and participated in three annual races before emerging third time lucky." The jockey stands with the reins atop a light twowheel carriage to which the two oxen are hitched before the race begins.
