NEW DELHI: India's private sector economy continues to thrive, reflecting robust growth as highlighted by the latest HSBC Flash PMI survey compiled by S&P Global.

In October, the composite output index registered a strong 58.6, indicating expansion for the thirty-ninth consecutive month. This figure marks an increase from September>s final reading of 58.3, surpassing the long-run average of 54.7 and illustrating the resilience of the Indian economy amid global

The landfall of 'Dana' started around 12.05 am on Friday between Bhitarkanika in Kendrapara and Dhamra in Bhadrak district of Odisha with wind speeds of around 110 kmph.

Punjab's Farmers suffer as AAP Government fails to procure crop: Capt Amarinder Singh



Former CM Slams CM **Bhagwant Mann for Inaction**

KHANNA: Former Punjab Chief Minister and senior BJP leader Captain Amarinder Singh visited Asia's largest grain market, Khanna Anaj Mandi, to assess the ground situation and met with farmers, arthiyas, and laborers. Expressing deep concern over the plight of Punjab's farmers, he lambasted the AAP government for its failure to procure the PR126 paddy variety, leaving farmers in distress.

The situation is alarming. During my tenure, no farmer had to sleep in the mandi even once. They would bring their produce, it would get procured, and they would get money in their accounts all in one day. Today, farmers are sitting with their crop in mandis for 10 days, and it's not even being procured at MSP," Captain Amarinder Singh said.

He questioned CM Bhag-

want Mann's absence from the mandis, saying, "Why hasn't the Chief Minister visited any mandi even once? Why isn't his Food and Agriculture Minister coming to address the concerns? The overnment encouraged farmers to sow PR126, but now they're running away

from procuring it." Captain Amarinder Singh pointed out that CM Bhagwant Mann lacks governance experience, and AAP leaders have no expertise. "Before the season began, the CM should have resolved issues by visiting the central government. The AAP government is ruining Punjab due to ego and power

Highlighting the stark contrast, Captain Amarinder Singh noted, "No CM, minister, or even MLA has visited mandis recently to address these concerns. During my 10-year tenure, we ensured seamless procurement. I fulfilled my CM and securing funds. Former CM Parkash Singh Badal also worked tirelessly for Punjab's welfare by engaging with the center when needed.'

To ensure quick resolution, Captain Amarinder Singh promised, "I will personally meet with Prime Minister Narendra Modi ji, Home Minister Amit Shah ji, and Food & Distribution Minister Pralhad Joshi to address this ssue, which should have been Bhagwant Mann's responsibility in the first place.

He emphasized that the Centre had already sent Rs 44,000 crores to the Punjab government for procurement. "I will also urge the Centre government to ensure that arthiyas get compensation for the PR126 crop. How can they pay for the gap from their own pockets?'

The allegations of Centre's indifference are baseless. Punjab has always had different governments at the Centre and state, but this problem of non-lifting never arose before. It's a clear failure of the AAP government," he asserted.

In the face of the growing menace of disruptions and bomb hoaxes, rail and air transport is under threat. The return of underworld activities in Mumbai is also an emerging concern. Are our security preparations in place?

n recent weeks, India has witnessed disturbing disruptions to critical infrastructure, threatening the fabric of our daily lives. From railway tracks to airline operations and even Bollywood, the shadow of terrorism looms large. It began with bizarre obstacles placed on railway tracks - electric poles, gas cylinders, stones, motorcycle wheels, and iron pieces – to disrupt train movements. The consequences were devastating: several derailments and accidents, claiming precious lives and causing widespread destruction.

Unfortunately, the focus has now shifted to air traffic also, with a surge in hoax bomb calls and messages on social media. In just one week, airlines received nearly 100 bomb threats, causing immense losses to Air India, Vistara, IndiGo, and others. Airlines are bearing the brunt of bomb hoaxes, incurring significant expenses ranging from fuel dumping using ultrasonic flaw detecand aircraft grounding to accommodating passengers and crew in hotels. According to estimates, a single hoax incident can result in losses exceeding eliminate human error; using Rs 3 crore. The government is currently assessing the threat ing systems on hundreds of messages, with the civil aviation minister suggesting that it may be the work of a prankster or minor every time using a new

Some of the measures taken by the railways include replacing old tracks to prevent accidents; tion machines and electronic monitoring of track geometry; relying on electrical and electronic interlocking systems to train protection and warnroute kilometers; eliminating unmanned level crossings; and increasing smart coaches, online monitoring, and GPSanonymous X account (earlier

These disruptions have raised concerns about the identity and motives of those responsible. While investigations are ongoing, several possibilities emerge. Terrorist organizations, international or local outfits, may aim to create fear and disrupt critical infrastructure. Alternatively, anti-social elements seeking thrill or revenge may exploit vulnerabilities. Lone wolves, individuals with grievances or extremist ideologies, may also act alone.

However, identifying and apprehending the culprits has proven challenging. One major hurdle is the lack of intelligence, which hampers investigations. Furthermore, perpetrators use sophisticated methods, including encrypted communication, proxy servers, and anonymous accounts, complicating tracking efforts. Limited resources, including manpower, technology, and expertise, constrain law enforcement agencies. Additionally, coordination issues between agencies and information-sharing gaps hinder progress.

Unraveling intricate plots and identifying culprits requires time and expertise, making investigations complex. To based trackers. How effective overcome these challenges, en-

and sharing is crucial. Leveraging technology, such as AIpowered tools, data analytics, and cyber forensics, can also aid investigations. Strengthening inter-agency coordination, increasing public awareness, and encouraging vigilant reporting are essential. Providing special-

ized training for investigators

will also help.

By addressing these aspects, India can improve its response to disruptions and ensure safer transportation services. Effective collaboration between law enforcement agencies, intelligence units, and transportation authorities is vital. The government must prioritize investing in cutting-edge technology and training to combat these evolving threats. As terrorism evolves, so must our response. Enhanced coordination, technology integration, and public awareness are crucial to containing these disruptions. The intelligence community must adapt to stay ahead of these threats. We cannot afford to let terrorism disrupt our daily lives. The time to act is now!

India and China relations need a cautious reset


tober 22, 2024, of an agree-

ment to resolve its four-year military standoff with India marks a significant moment for bilateral relations. The announcement, following Indian Foreign Secretary Vikram Misri's statement a day earlier, signals a breakthrough in a strained relationship since the April 2020 transgressions along the Line of Actual Control (LAC). These incursions, followed by the tragic Galwan Valley clashes that claimed the lives of 20 Indian soldiers, had brought diplomatic ties to a standstill. While both countries managed disengagement at key friction points, the mistrust, particularly over China's willingness to revert to the "status quo ante," has lingered. External Affairs Minister S. Jaishankar's assertion that China has agreed to restore troop positions to pre-2020 levels is a welcome development, but it requires verification. If true, this could be a crucial step towards rebuilding trust between the two nations. The timing of the agreement, ahead of the BRICS Summit in Russia, opens the possibility of a formal interaction between Prime Minister Narendra Modi and President Xi Jinping-an opportunity to rekindle dialogue, something absent since their last one-on-one meetings before 2020. However, the Indian government must proceed with caution. Transparency in the execution of the next steps, as referenced by Misri, is essential to address the domestic perception that Chinese troops may still control areas previously patrolled by Indian soldiers. The government's reluctance to fully brief Parliament or grant media access to forward areas has compounded suspicions. Lessons from past engagements, such as the post-Doklam scenario, must guide a measured response. Both nations should also revisit their existing border management frameworks to see if they remain viable for maintaining peace. Only a cautious and informed approach will ensure lasting stability

render arms and join mainstream, or face action, Amit Shah tells Naxals". The ground zero of the current phase of left-wing extremism activities, where most of the recent and successful tactical operations by security forces have been conducted, is the Bastar division of Chhattisgarh. It comprises the districts of Bastar, Narayanpur, Bijapur, Kondagaon, Sukma, Dantewada and Kanker.

An indication of the government's approach

The Home Minister's meeting with the victims is encouraging indeed when seen through the prism of successes of the security forces in counter-Maoist operations over the last six months or so. The initiative indicates the seriousness of the government to address the challenges in a manner that is beyond the realm of law and order. The government's declared approach to deal with left-wing extremism has been to address the challenge in a holistic manner, in the areas of security, development, ensuring the rights of local communities, and with improvements in governance and public perception management. However, the parameters of success and performance on the ground have continued to be contextualised by the security bias of the approach.

In the context of addressing the conditions of victims, it may be relevant to invoke recent public statements by the Deputy Chief Minister and Home Minister of Chhattisgarh, Vijay Sharma. In May



this year, Mr. Sharma had said that the State was making efforts to bring in new features and have better implementation in maintaining the victims' register for people victimised due to violence in Bastar. An alignment in the thought processes of policymakers at the Centre and in the State bodes well for the resolution of the leftwing extremism challenge in the long run, wherein we move beyond our delusionary race to kill the last Maoist.

Categories of those affected

However one needs to tread ahead with the policies and their implementation, with a caveat that victim identity is not a monolith in conflict zones — and Bastar is no different. Two main categories of victims among several, are, first the ones who have suffered at the hands of Maoists (and presumably these were the people who met the Home Minister). The second category of victims who cannot be ignored comprise those who have suffered at the hands of the state to include security forces and the criminal justice system; intentionally or otherwise.

Another agency that victimised the tribal community was the vigilante army called the Salwa Judum during the middle years of the first decade of this century. In this period, in addition to people who fled their villages to live in Salwa Judum camps (where they continue to live even after two

decades), about

55,000 tribals fled Chhattisgarh to take shelter in then unified Andhra Pradesh. These internally displaced conflict victims yearn to return to Chhattisgarh but are yet to get redress from the respective State governments. In addition, there are numerous victims of structural violence churned up by the conflict since the 1980s, when Maoist cadres entered the forests of Dandakaranya, seeking safe haven. Dandakaranya covers an area of about 92,000 square kilometres and includes parts of Chhattisgarh, Odisha, Telangana, Andhra Pradesh and Maharashtra.


In fact the victimisation as a result of structural violence vis-à-vis tribal communities has been an ongoing process since colonial times and through the post-independence era. The Maoists, after entering Dandakaranya, sought to champion the tribal cause that was a manifestation of centuries of victimisation. Absent governance resulting from the policy of exclusion of tribal belts, gave tremendous elbow room to the Maoists to fill in the gap left by the state.

Making it work

The initiative to identify victims and register the details in the victims' register — talked about by Mr. Sharma — has tremendous potential to alleviate the plight of tribal communities who find themselves sandwiched between the Maoists and the state. The victims' register, as an experiment, has been tried in more than a dozen countries as a conflict resolution or peacebuilding effort. Such an effort played a major role in resolving the deeprooted left-wing extremism insurgency in Colombia.

However, the exercise of identifying victims shall have to be in the spirit of truth and reconciliation and agnostic to the nature of the perpetrators who carried out victimisation. If otherwise, such a wellintentioned exercise may end up creating divides in the society, as another version of the haves versus the have-nots conflict. As far as the rules of the victims' register experiment are concerned, victims and their families need to be given a benefit of doubt when they tell their stories, as many versions cannot be cross-checked in a tangible manner. The ground rules of the exercise shall have to be based on trust. The said measure shall be an impactful confidence-building measure and is bound to expand the support base of the state against the Maoists. The time is ripe to embark on a journey to address tribal aspirations. And pitfalls in the journey may well be afforded in times of the Maoists being at their lowest.

$The job\ crisis\ undermines\ state\ legitimacy$



ndia is not producing enough good quality jobs for its people. A good quality job provides dignity, adequate compensation, an opportunity for learning, and advancement for those who strive. Instead, many jobs are unpaid, informal, and dead end. Worse, the seemingly low unemployment rate masks the fact that to count as employed, a person needs to have reported working for only one month in an entire year.

The dearth of quality employment, particularly among the youth, is a ticking time bomb that threatens not just our economy, but the very legitimacy of our state. If the government fails to create avenues for social and economic participation for young people, it will inevitably breed frustration.

The political problem is twofold: how do we give people a sense of dignity and purpose, and the means for financial support? Traditionally, people have derived dignity and purpose through a combination of community, work, and political engagement. However, the package deal of liberalism and capitalism have deprioritised traditional sources of community and increased the importance of work in conferring social standing and belonging. As a result, work has become the dominant entry point into a broader sense of community and political engagement.

While the elite find purpose and status through their control over societal discourse and decision-making, which also bring them substantial financial rewards, large sections of our population feel they lack both dignity and financial security. This disparity is likely to worsen as technological advancements and capital concentration potentially displace large



numbers of workers, perhaps permanently. In a large democracy such as India, such concentration of purpose and financial gain among the elites can erode faith in the system and lead to political instability.

This challenge — how we structure our society, what we value, and how we include everyone — is fundamentally political. Yet, the political response has been inadequate, oscillating between deferring to market forces and resorting to shortterm partisanship. The market-oriented approach is reflected in the superficial mantra of 'creative destruction,' suggesting that old jobs and industries will be seamlessly replaced by new and better ones. Meanwhile, some politicians and capitalists have mooted universal basic income (UBI) as a solution. UBI is a minimum "income" received by all citizens of a given population as financial transfers from

the government without having to work. Setting aside the question of UBI's financial feasibility, it is important to recognise

that inequality and an assault on human dignity are inherent in the very concept. UBI implies that a significant portion of the population is no longer needed in the economy, with a smaller subset "paying" for the rest. Its very premise concedes that technology and capital will create outsized winners while the majority will merely survive on their largesse. This approach fails to address people's need to feel relevant and

capable, and ignores the loss of dignity that comes from not contributing meaningfully to society. It does not, thus, account for the possibility that UBI might encourage more anger and populism because people want to contribute and thrive, not just survive on the sidelines.

There is a risk to democracy as a whole as well. UBI would shift focus from structural reforms to mere economic transfers and thus entrench elite power by insulating them from pressures to address fundamental inequities in the economy and labour markets. It risks recasting the state as a mere distributor of funds rather than the architect and arbitrator of societal processes required to create a just and participatory social and economic system.

The partisan response has been to lob the issue between parties for short-term electoral gains instead of responding to the ongoing structural transformation of our society. Some political leaders are mindful of the long term, but institutionally, parties have become too narrow in their scope to address larger questions such as unemployment and have reduced their ambitions to winning elections alone. However, divesting societal issues to civil society or government in order to function solely as election-winning machines jeopardises their long-term legitimacy. This is because democracy is about more than elections — it is about creating a social contract that works for everyone.

In fact, the failure to anticipate and address long-term structural issues is a key reason why people feel neglected by the political class and view politics as a cynical game. When people believe the political system is incapable of addressing pressing challenges, they lose faith in democratic institutions. Thus parties and institutions must find ways to address structural issues, including unemployment, inequality, and dignity; else, people will seek alternatives, rendering political parties irrelevant. We are witnessing this globally through the rise of populism, authoritarianism, and civic disengagement.

Political parties must provide meaningful leadership by addressing structural issues head-on without resorting to deflection or partisanship. The future of Indian democracy — and the continued relevance of our political institutions — hinges on our ability to restore a broader sense of public purpose and economic participation to the centre of our national dialogue.

Beyond the Bell: Resilience and future of female boxers

ita Bullwinkel's debut novel, Headshot, longlisted for the 2024 Booker Prize, offers an insightful and poignant exploration of young women competing in the traditionally male-dominated world of boxing. Though boxing is often seen as a celebration of masculinity, as depicted in popular culture through figures like Muhammad Ali and movies such as Raging Bull, Headshot delves into the untold stories of female boxers who fight for more than just victory in the ring. Bullwinkel's narrative focuses on eight teenage girls, each a finalist at the 12th annual Women's 18 and Under Daughters of America Cup, painting a vivid portrait of their struggles both in and outside the boxing ring.

Set in Reno, Nevada, the novel's core strength lies in its characters, who come from diverse social, economic, and cultural backgrounds, and carry their personal traumas into their fights. Each girl has her

reasons for stepping into the ring, and Bullwinkel skillfully weaves their motivations into the narrative, making their battles feel as much about overcoming life's challenges as they are about winning the tournament.

The standout characters include Artemis Victor, who hails from a family of boxers, and her first-round opponent, Andi Taylor, a lifeguard struggling to keep her head above water in more ways than one. Bullwinkel doesn't merely depict the sport; she uses boxing as a metaphor for life's battles, with each girl's fighting style reflecting her personal history. For instance, Rachel Doricko, who witnessed her home burn down as a child, channels her trauma into both running and boxing as coping mechanisms. Similarly, the cousins Izzy and Iggy Lang, from Michigan, each struggle with familial expectations and self-worth as they try to carve out identities separate from

their roots.
One of the novel's most compel-

ling elements is how Bullwinkel connects the girls to their pasts through seemingly innocuous childhood memories, such as hand-clapping games. Rose Mueller and Tanya Maw, two competitors from different regions, unknowingly share these playful traditions, and their synchronized punches during a fight echo the rhythm of those long-ago games. This blend of past and present creates a lyrical depth to the fights, illustrating how the girls' identities are intertwined with their experiences growing up.

Though the novel centers around the boxing tournament, it also provides glimpses into the futures of these young women, a device that adds emotional weight to the narrative. Bullwinkel's portrayal of their lives post-boxing brings a sense of closure to their stories, but it also evokes a bittersweet nostalgia for their youth and the fleeting nature of athletic glory. Andi, who takes a beating from Artemis, will eventu-

ally become a pharmacist. Artemis herself will become a wine distributor, although injuries from her time in the ring will prevent her from even holding a cup of tea when she reaches 60. Another character, Kate Heffer, whose eye swells to the size of a tennis ball during her match, will go on to become a successful wedding planner.

What makes Headshot stand out is Bullwinkel's ability to humanize these girls beyond the boxing ring. By mapping their futures, she emphasizes that while their boxing days may be forgotten, their lives are still full of purpose and light. The juxtaposition between the violent, bruising world of boxing and the quiet, often unremarkable futures these women face is handled with grace and tenderness.

However, the novel's final chapter, titled "The Future," feels somewhat dissonant from the rest of the narrative. Bullwinkel ends with a hopeful message about the endless cycle of girls taking up sports, noting that "girls are infinite backwards and forwards." While this sentiment is optimistic, it contrasts with the reality that none of her protagonists continue with boxing after the tournament. This disconnect between the narrative arc and the final message leaves the reader wondering if the conclusion fully aligns with the novel's deeper themes of transience and impermanence.

Despite this minor quibble, Headshot is a powerful and evocative novel that challenges conventional portrayals of both boxing and femininity. Bullwinkel shines a spotlight on the emotional and physical tolls of competition, while also celebrating the strength and resilience of her young protagonists. In Headshot, the ring is not just a place for punches—it's where these girls fight for their sense of self, their futures, and the recognition they deserve in a world that often overlooks them. Through her nuanced storytelling, Bullwinkel ensures that their voices are heard loud and clear.

RBI Deputy Governor Projects India's Return to 8% Growth Path by 2026

India Deputy Governor Michael Debabrata Patra has projected Indias return to its long-term growth trajectory of 8 percent, following anticipated growth rates of 7.2 percent in FY25 and 7 percent in FY26.

Speaking at the Federal Reserve Bank>s New York Fed Central Banking Seminar on Monday, Patra described these intermediate figures as part of a cyclical correction following the pandemic rebound.

The deputy governor emphasised the critical importance of robust macroeconomic fundamentals and substantial financial buffers in safeguarding against global economic risks.

This strategy appears to be yielding results, as evidenced by India>s foreign exchange reserves reaching a historic peak of USD 704.9 billion on September 27, before moderating to USD 690.4 billion by October 11.

These reserves now provide



coverage for 11.8 months of imports and exceed 101 percent of the nation>s external debt as of June 2024. India>s performance in building its foreign reserves has been particularly noteworthy in 2024, with a net increase of USD 68 billion through October 11, positioning the country as the second-largest accumulator of foreign reserves among major economies, surpassed only by China. Addressing inflation concerns, Patra acknowledged

to continue through October and November.

Gold drops Rs 1,150 to Rs 80,050 per 10 grams; silver declines Rs 2,000

NEW DELHI: Gold price dropped Rs 1,150 to Rs 80,050 per 10 grams in the national capital on Friday on slackened demand from jewellers and retailers, according to All India Sarafa Association.

Silver also remained under selling pressure and slipped below the Rs 1 lakh mark by declining Rs 2,000 to Rs 99,000 per kg. The metal had closed at Rs 1.01 lakh per kg in the previous close on Thursday.

Additionally, gold of 99.5 per cent purity fell Rs 350 to Rs 80,450 per 10 grams against the previous close of Rs 80,800, while the precious metal of 99.9 per cent purity declined Rs 1,150 to Rs 80,050 per 10 grams against Rs 81,200 on Thursday.

Traders said tepid demand from jewellers and retailers in the local markets and a weak trend in the overseas markets weighed on gold prices.

In futures trade on the Multi Commodity Exchange (MCX), gold contracts for December

delivery declined Rs 406 or 0.52 per cent to trade at Rs 77,921 per 10 grams.

Silver contracts for December delivery plummeted Rs 1,134 or 1.17 per cent to Rs 95,898 per kg on the bourse.

GoM proposes GST rate changes on Cycles & 20-Litre bottles to be brought down

NEW DELHI: The Group of Ministers (GoM) has proposed a series of Goods and Services Tax (GST) rate adjustments expected to generate an additional Rs 22,000 crore in revenue.

The proposals, formulated during a meeting on Saturday, include both increases and reductions in tax rates across various product categories. Led by Bihar Deputy Chief

Minister Samrat Chaudhary, the GoM has recommended elevating the GST rate on luxury items. Notably, high-end wristwatches priced above Rs 25,000 and premium footwear exceeding Rs 15,000 may see their tax rates increase from 18 percent to 28 percent.

Conversely, the panel has suggested tax reductions on several everyday items. The GoM proposes lowering the GST rate on 20-litre packaged drinking water bottles and bicycles priced below Rs 10,000 from 18 percent and 12 percent, respectively, to 5 percent.

Exercise notebooks may also benefit from a tax reduction, with a proposed decrease from



12 percent to 5 percent.

The recommendations also include potential tax exemptions for term life insurance premiums and health insurance premiums paid by senior citizens, a move aimed at easing the financial burden on both insurers and policyholders.

These proposals follow recent GST Council decisions, headed by Finance Minister Nirmala Sitharaman, which saw rate reductions on cancer drugs and selected snack items in September.

The ministerial panel is expected to submit its compreensive recommendations to the GST Council by October 31.

The final decisions on these proposed rate adjustments will oe made during the next GST Council meeting, where the suggestions will be reviewed and

According to "The Rob Re- **BENGALURU**: At a meeting in Gandhinagar, European Investment Bank (EIB) Vice-President Nicola Beer and Director of Finance of Karnataka Rail Infrastructure Development Company Ltd (KRIDE) Awadhesh Mehta formally announced a €300 million loan to build a new suburban railway network covering four dedicated rail corridors in Bengaluru. The network will stretch over a total of 149 km and include 58 stations and two depots.

Home to around 14 million people (expected to reach 20million by 2030), Bengaluru is India's third most populous city. The EIB has already supported the city's transportation congestion, air and noise pollutor with a €500mi lion loan Metro R6 line and purchase an affordable mobility solution

nancing of metro investment in Agra, Bengaluru, Bhopal, Kanpur, Lucknow and Pune, with a total of €3.25 billion committed since 2016. This makes India the largest beneficiary of EIB transport financing outside

The Bengaluru suburban railway is expected to unlock significant synergy effects with the existing rail operation, as well as with the metro system, by creating multimodal transport hubs with several interconnecting stations to facilitate a seamless transfer between different public transport modes. The project promotes a modal shift from road to rail and addresses ion, road safety and gree a fleet of about 96 metro cars. to improve access to jobs and

Once the project is fully oper-

ational, the Bengaluru transport system will see a 43% drop in CO₂ emissions. Estimated daily ridership will be approximately 400000 trips per day in 2029, the first year of full operation, and is expected to increase to about 1.4 million trips per day in 2040, largely aligned with the projected population growth.

EIB Vice-President Nicola Beer said: "The European Investment Bank is honoured to finance the Bengaluru suburban railway network with a €300million loan. This funding complements the €500 million we allocated for the construction of the Bengaluru Metro R6 line, addressing Bengaluru's mobility challenges by developing a clean, modern and efficient public transport system. The two projects we are financing in Bengaluru aim to create India's most integrated rail network, providing seamless connectivity with all other modes of public transport in the city. The Bengaluru suburban railway network includes design features to enhance access, safety and security for women, and supports women's participation in construction works. India's GDP to grow at 7% in current fiscal, 6.5% in FY26: IMF



NEW DELHI: India's GDP growth is likely to moderate from 8.2 per cent in FY24 to 7 per cent in FY25 and 6.5 per cent in FY26 because the pent-up demand accumulated during Covid has exhausted, as the economy reconnects with its potential, the International Monetary Fund (IMF) said on Tuesday.

About the global economy, the IMF said the battle against inflation has largely been won, even though price pressures persist in some countries.

After peaking at 9.4 per cent year over year in the third quarter of 2022, headline inflation rates are now projected to reach 3.5 per cent by the end of 2025, below the average level of 3.6 per cent between 2000 and 2019, it said.

The annual World Economic Outlook released here projected global economic growth to stay steady at 3.2 especially low-income developing countries, have seen sizable downside growth revisions.

NEW DELHI: Top economists on Wednesday hailed India's GDP projections from global financial institutions like the **International Monetary Fund** (IMF) and Deloitte, saying the surge in rural consumption was primarily driving the country's GDP growth story.

The International Monetary Fund (IMF) maintained its India growth rate projection at 7 per cent in the current fiscal year. According to Deloitte, India's annual GDP growth was projected to be between 7 and 7.2 per cent in FY 2024-2025, which was in line with the Reserve Bank of India's (RBI) prediction of the country witnessing real GDP growth at 7.2 per cent for FY25. Sanju Verma, an economist and national spokesperson of the BJP, told



IANS that the average monthly income of rural households in India has increased by almost 58 per cent over five years as per the latest survey by the National Bank for Agriculture and Rural Development (NABARD), and that was amply evident from what the festival season sales numbers look like in rural areas.

"The purchasing power was certainly intact and a large chunk of the festival season sales

were being driven by rural and semi-urban India, once again endorsing the fact that the rural growth story in India was firing on all cylinders, "she emphasised. It was not just the GDP growth trajectory, which under the leadership of Prime Minister Narendra Modi, was slated to be intact but the moot point here was that while GDP growth was moving upwards, inflation was

slated to move southwards.

KAZAN: Highlighting the time-tested India-Russia partnership and his friendship with Prime Minister Narendra Modi, Russian President Vladimir Putin on Tuesday emphasised that the bond between the two countries is so strong that PM Modi would understand him without needing the help of any translator.

Putin made the remark as both leaders sat down for bilateral discussions in Kazan on the sidelines of the 16th BRICS Summit.

"Our relationship is so tight that you will understand me without any translation, "said the Russian President, sparking laughter in the room at the Governor's Palace.

The Russian President recalled PM Modi's visit to Moscow in July, the "fruitful negotiations" that were held and thanked the Indian Prime Minister for accepting his invite and coming to Kazan for the BRICS summit.

However, FM Sitharaman stressed that the need of the hour is a more comprehensive, multi-sectoral analysis — one that examines how emerging trends interact and influence both job loss and job creation.

"This analysis should also consider factors like geopolitical fragmentation and its effects on sectors such as food production, exports, and related employment, "FM Sitharaman added. In addition to the traditional manufacturing-led development

highlighted the need to explore alternative growth strategies and the types of jobs they will generate. "The Union Finance Minister urged the @World-Bank to collaborate with countries in identifying high-priority skilling sectors based on data, analysis, and knowledge work, with a focus on generating employment, skill matching, and labour retention," the Ministry of Finance posted on X social media platform.

FM Sitharaman also underscored the importance of an outcome-oriented road map with a clear implementation strategy to effectively put these plans into action. According to the ministry, FM Sitharaman also met UK Chancellor Rachel Reeves on the sidelines of the annual meetings in Washington DC and discussed bilateral issues. "The Finance Minister said that India looks forward to the next Economic and Financial Dialogue during the first half of next year in London," the minister said.

Had 'good agreements' with PM Modi on expanding Iran-India ties, says Pezeshkian



KAZAN (RUSSIA): Iranian President Masoud Pezeshkian on Wednesday said that he had "good agreements" with Prime Minister Narendra Modi about expanding cooperation between Iran and India during Tuesday's bilateral meeting between the two leaders held in the Russian city of Kazan on the sidelines of the BRICS summit.

"We had good agreements about expanding cooperation between Iran and India, aiming to create prosperity and security for both countries and region, as well as the idea of creating a communication network between the countries of the region, the results of which will be seen in the economies of the two countries, "Pezeshkian posted on X late Wednesday afternoon.

During the meeting - the first since Pezeshkian's election as the ninth President of Iran in July following Ebrahim Raisi's death in a helicopter crash on May 19 - PM Modi had reaffirmed India's commitment to deepening the age-old bilateral ties with Iran. The Iranian president, while

referring to Israel's assassination of Hamas political leader Ismail Haniyeh in Tehran on July 30 - the day he took over as Iran's President - said that the killing had hampered the goals set by his government, including enhancing reconciliation inside Iran as well as boosting ties with neighbouring and regional countries. "We believe that war hampers the development of countries, and that is why we have been, and are, decisively seeking to prevent the spread of tension and conflict in the region, Pezeshkian said. Prime Minister Modi, meanwhile, expressed deep concern over the widening of the conflict in West Asia and reiterated India's call to deescalate the situation. The two leaders reaffirmed Chabahar's significance for reconstruction and redevelopment of Afghanistan and enhancing trade and economic linkages with Central Asia. As India reckoned that the development of Chabahar Port is the biggest pillar of New Delhi's ongoing cooperation with Tehran, Pezeshkian expressed hope that the impleme bilateral agreements, including the one to develop Chabahar Port, is accelerated.

Sakshi Malik, in her book Witness' published by Chiki Sarkar of Juggernaut Books reveals incidents of her wrestling career, a really honest account of her life — the highs, lows, and everything in between of her literary, professional, ventureI great memoirs in this book, she said.

A recent controversy reveals that Babita Phogat wanted to become Wrestling Federation of India (WFI) chief, provoked wrestlers to protest against Brij Bhushan Sharan Singh sexually harassing the female wrestlers. The charges framed by a handful of wrestlers against Brij Bhushan ran Singh, WFI chief allegedly sexually harassing the female wrestlers, attracted headlines in the newspapers for a long time when allegations were imposed and a case was also registered against him. Olympic bronze medalist and former wrestler Sakshi Malik said that Vinesh Phogat and Bajrang Punia's decision to take exemption from Asian Games trials last year affected the image of their protest against Brij Bhushan Sharan Singh since it was made for selfish motives. Sakshi was also one of the three main wrestlers of this protest held at Jantar-Mantar



also accused former wrestler and now a political leader Babita Phogat of taking advantage of the protest for her own selfish interests claiming that she wanted to become WFI chief and encouraged wrestlers to protest.

Sakshi, Bajrang and Vinesh, the three had accused former WFI chief Brij Bhushan Sharan Singh of sexually harassing female wrestlers during his tenure and the case is still going on in a Delhi court. After the suspension of WFI, the ad-hoc committee started looking after the functioning of wrestling which gave Bairang and Vinesh exemption in the trials for the 2023 Asian Games but Sakshi decided not to do so despite the suggestion of her colleagues. Ultimately New Delhi attracting not only Sakshi could not participate

in the Asian Games because Vinesh was injured before the Games and Bajrang failed to win a medal. However, Sakshi did not disclose the names of those who convinced Bajrang and Vinesh to join the game to tarnish someone's image for their own selfish interests. 
