MCD presents ₹17,000 cr budget for 2025- BSNL Bounces Back Into Profit 26, prioritizes sanitation and infrastructure for First Time Since 2007

The Municipal Corporation of Delhi (MCD) on Thursday unveiled its budget for the next financial year, proposing an outlay of Rs 17,000 crore. with the highest allocation of Rs 4,907.11 crore directed towards sanitation. Apart from sanitation, the budget emphasizes infrastructure development, education, and waste management

In a significant move towards waste management, MCD has announced the establishment of waste-to-energy plants in Narela-Bawana (3,600 TPD) and Ghazipur (3,000 TPD). Additionally, bio-CNG plants in Okhla, Ghogha Dairy, and Ghazipur will process 750 metric tons of waste daily. The civic body is also working on setting up bio-methanisation plants with a capacity of 200 metric tons



per day, expected to be operational by March 2025.

As part of its green initiatives, MCD has planted over 1.8 lakh trees by December jor initiatives including the 2024 and developed eight Miyawaki micro-forests. However, the horticulture department's budget has been reduced to Rs 393.26 crore from Rs 586.58 crore last year.

While presenting the budget for 2025-26, MCD Commis- MCD hospitals recorded 58 sioner Ashwani Kumar high- lakh patient visits between

April and December 2024, while 180 new medical officers were recruited. The corporation aims to generate Rs 4,300 crore in property tax revenue for 2024-25, with total projected income for 2025-26 standing at Rs 16,70,104.70 lakh. Additionally, MCD has secured a BBB(-) credit rating and settled Rs 450 crore in outstanding dues under the Seventh Pay Commission.

Key infrastructure projects include the Rs 64.38 crore Sultanpuri railway crossing project, the Rs 48.77 crore expansion of Kishanganj R.U.B., and a nearly completed Rs 116 crore building in Karkardooma. The construction of Lajpat Nagar Colony Hospital has been finalized, while 36 waste disposal sites have been earmarked for development.

NEW DELHI: State-owned telecom major Bharat Sanchar Nigam Limited (BSNL) on Friday reported a profit of Rs 262 crore in the third quarter of the current financial year, marking its first return to profitability since 2007.

This milestone reflects the company's focus on innovation, aggressive network expansion, cost optimisation, and customer-centric service improvements, the BSNL said in a statement

BSNL chairman and managing director A. Robert J. Ravi, said: "We expect revenue growth to improve further, exceeding 20% by the end of the financial year. Revenue from Mobility, FTTH, and Leased Lines has increased by 15 per cent, 18 per cent, and 14 per cent, respectively, over Q3 of the previous year.

Additionally, BSNL has successfully reduced its finance cost and overall expenditure, leading to a decline in losses

pared to last year, he pointed out. The government's suport through strategic revival initiatives, including spectrum allocation, and capital infusion have played a key role in bolstering our operations, Ravi said. He said that BSNL has introduced new innovations such as National WiFi Roaming, BiTV - Free Entertainment for all mobile customers, and IFTV for all FTTH customers.

The continuous focus on quality of service and service assurance has further strengthened customer trust and reinforced the BSNL's position as a leading telecom service provider in India, Ravi said. "This Rs 262 crore profit underscores the BSNL's resurgence and

long-term sustainability. As we continue on this growth trajectory, we remain committed to delivering higher value to our shareholders, expanding market opportunities, and driving innovation," he added.

The BSNL posted a robust double-digit growth across also its services with mobility services revenue growing by 15 per cent during the October-December quarter, Fiber-to-the-Home (FTTH) revenue increasing by 18 per cent and leased line services revenue clocking a 14 per cent jump over the same quarter of the previous year.

The BSNL has been aggressively expanding its network with an accelerated 4G rollout and fiber-optic infrastructure upgrades.

It has also strengthened connectivity across urban and rural areas and introduced customer-centric digital innovations with national WiFi roaming for seamless internet access across networks, the BSNL chief added.

HM Shah Reviews Implementation Of Three New Criminal Laws In Maharashtra



Minister Amit Shah on Friday chaired a review meeting on the implementation of three new criminal laws in Maharashtra asking the state to establish a model Directorate of Prosecution system in line with the new criminal laws.

In the presence of Chief Minister Devendra Fadnavis, HM Shah reviewed the implementation and present status of various new provisions related to police, prisons, courts, prosecution, and forensics in the state.

The meeting was attended by the Union Home Secretary, the Chief Secretary and Director General of Police of Maharashtra, the Director General of the Bureau of Police Research and Development (BPRD), the Director General of the National Crime Records Bureau (NCRB). and other senior officials from the Union Home Ministry and the state government.

position (LoP) Rahul Gandhi reacting to the Manipur Chief Minister N.Biren Singh's resignation, said that he quit the post following "mounting public pressure".

The LoP, who visited Manipur three times after the ethnic violence broke out on May 3. 2023, in a post on the X said: "For nearly two years, BJP's CM Biren Singh instigated division in Manipur. PM Modi allowed him to continue despite the violence, loss of life, and the in Manipur.

He added that the resignation of Biren Singh shows that mounting public pressure, the SC investigation and the noconfidence motion by the Congress have forced a reckoning.

"But the most urgent priority is to restore peace in the state and work to heal the wounds of the people of Manipur. PM Modi must visit Manipur at once, listen to the people and finally explain his plan to bring back normalcy," he said.

The LoP's third visit came during the second leg of his Bharat Jodo Nyay Yatra, which started from Manipur on January 14 last year. The 67-day-long Yatra ended in Mumbai cover ing 85 districts of 14 states.

The Congress kicked off the Bharat Jodo Nyay Yatra from Manipur with a promise to "bring peace and harmony" to the ethnic violence-hit state.

LoP Rahul Gandhi in his speech in the parliament and outside the parliament urged Prime Minister Narendra Modi to visit Manipur and restore peace and normalcy.

Meanwhile, Congress General Secretary and parliament member Jairam Ramesh said that the Congress was all set to move a no-confidence motion against the Chief Minister and his Council of Ministers in the Manipur Assembly on Monday and sensing the climate, the Manipur CM has resigned.

"This was a demand that the Congress has been making since early May 2023, when Manipur erupted. The Chief Minister's resignation was belated. The people of Manipur now await a visit by our Frequent Flier PM who is off to France and the USA now - and who has found neither the time nor the inclination to go to Manipur these past twenty months," Ramesh, who also visited Manipur several times during the past two years after the ethnic violence started, said in a post on the X.

The swearing-in ceremony of the newly elected Bharatiya Janata Party (BJP) government in Delhi is likely to take place on February 19 or 20, with the new dispensation prioritizing clean drinking water supply and improved civic infrastructure, party leaders said on Wednes-

Newly elected BJP MLA and party national secretary Manjinder Singh Sirsa stated that observers for the BJP legislature party meeting would soon be appointed following Prime Minister Narendra Modi's return from his foreign visit.

Rajouri Garden MLA, who is considered a strong contender for the post of Chief Minister or a ministerial berth. He further indicated that the BJP legislature party meeting was expected to be held around February 18-19, with the government formation likely to be completed by February 20, after the swearingin ceremony.



However, BJP legislators dismissed speculations about a contest for the Chief Minister's post, terming them as mere media conjecture.

New simpler Income Tax Bill slashes volume of Income Tax Act, 1961 by half

NEW DELHI: The Income-Tax Bill, 2025 tabled in Parliament on Thursday, marks a significant step toward simplifying the language and structure of the Income-tax Act, 1961 based on global best practices, according to a statement issued by the Finance Ministry.

The review has led to a substantial reduction in the Act's volume, making it more streamlined and navigable. The total number of words in the new Income Tax Bill has been reduced to 259, 676 in the new Income Tax Bill from a massive 512, 535 words in the existing Income Tax Act, 1961. This close to 50 per cent cut has resulted in a reduction of 252, 859 words, the statement said.

Accordingly, the number of chapters in the new Income Tax Bill has come down to 23 from 47 in the existing Income Tax Act, 1961. Similarly, the number of sections has been cut to 536 from 819 earlier which has resulted in removing as many as 283 sections, the statement explained.

This massive reduction has taken place with the simplification of language, making the law more accessible while the consolidation of amendments has reduced fragmentation. There has also been a struc-



tural rationalisation through tables and formulae for improved readability. Besides, the preservation of existing taxation principles has ensured continuity while enhancing usability, the statement said. Consultations were held

with industry experts and tax professionals and simplification models from Australia and the UK were studied for best practices.

The simplification exercise was guided by three core principles which include textual and structural simplification for improved clarity and coherence, ensuring continuity and certainty with no major tax policy changes and no modifications of tax rates to preserve predictability for taxpayers, the finance ministry said.

A three-pronged approach

was adopted with a focus on eliminating intricate language to enhance readability, removing redundant and repetitive provisions for better navigation and reorganising sections logically to facilitate ease of reference, according to the statement. The government also en-

sured widespread stakeholder engagement, consulting taxpayers, businesses, industry associations, and professional bodies. Out of 20, 976 online suggestions received, relevant suggestions were examined and incorporated, where feasible. The Income-tax Bill, 2025

reflects the Government's commitment to enhancing ease of doing business by providing a tax framework that is simple and clear, the statement added.

Anuj Dayal, Principal Executive Director, Corporate Communications, Delhi Metro, said that students showing their admit cards will also be prioritised while purchasing tickets at Ticket Office Machines (TOM) and Customer Care (CC)

New Government Must Strive to Make Delhi a **Model City for All: JIH Vice President Malik** Moatasim Khan

The Central Board of Secondary Education (CBSE) will commence the Class 10 and Class 12 board exams for 2025 on Saturday. This year, nearly 42 lakh students are expected to appear in the exams across 7, 842 centres in India and 26 countries abroad. To ensure the smooth con-

duct of the exams, the CBSE hosted a webcast on its official YouTube channel. The session provided guidelines for centre superintendents, deputy centre superintendents, assistant superintendents, city coordinators, and observers. It also covered evaluation protocols and the responsibilities of all officials

CBSE experts said students appearing for the exams must carry their admit cards along with their school ID cards.

Delhi's new CM to be chosen from MLAs, no deputy CM post



NEW DELHI: The Bharatiya Janata Party (BJP) will finalise the name for the Chief Minister's post in Delhi only after Prime Minister Narendra Modi returns from his US visit, sources said on Thursday, adding that the pick will be from the MLAs and there will be no deputy CM.

According to party insidrs, BJP National President J.P. Nadda has stated that the Chief Minister will be selected from among the elected MLAs, and the Legislature Party meeting to decide the leader will take place only after the PM's return. Sources have indicated that

one of the foremost priorities of the new BJP-led government will be the cleaning of the Yamuna River. Work on this front has already started, with the party keen on delivering on its promise of rejuvenating the heavily polluted river.

Additionally, the Ayushman Bharat health insurance scheme, which provides financial protection for medical expenses to underprivileged citizens, will be implemented in Delhi -- something the previous Aam Aadmi Party (AAP) government had not done.

Nadda also hinted that some major policy decisions are expected to be taken in the first cabinet meeting which is likely to be held immediately after the swearing-in ceremony.

Sources have also said that there will be no Deputy Chief Minister in the new BJP gov-

As the battle for Delhi's political landscape unfolded, the Bharatiya Janata Party (BJP) executed a meticulously planned electoral strategy, led by Union Home Minister Amit Shah and Delhi BJP President Virendra Sachdeva. Sources reveal that an internal survey was conducted to assess the party's standing before finalizing candidates, rejecting an initial list presented by the Delhi unit in December.

Following the Delhi polls, a follow-up meeting in January, attended by the top brass, ultimately shaped the final ticket allocations. The delay in announcing candidates despite receiving a staggering 2,100 applications—was a calculated move to minimize internal conflicts and consolidate support.

From MCD loss to strategic resurgence: BJP's electoral playbook took shape soon after its defeat in the 2022 Municipal Corporation of Delhi (MCD) elections, where it won 104 out of 250 seats, losing to the Aam Aadmi Party (AAP), which secured 134 seats. A senior BJP strategist remarked, "The setback in mmunal rhetori to a grassroots-driven model that expanded its vote share bevond 40%.

The transformation hinged on building 27 specialized cells and seven fronts, tailored to engage caste, regional, and religious groups. An active member of the BJP noted, "The Purvanchal Morcha and the newly

Caste equation: BJP's micro-targeting: Beyond religious outreach, the BJP fine-tuned its voter segmentation along caste and regional lines. The party categorized Delhi's migrant population, recognizing the distinct political behavior of Purvanchali and Uttarakhandi voters. The Purvanchali electorate, comprising 25% of Delhi's voters, had long been a stronghold for AAP leaders such as Sanjay Singh and Durgesh Pathak.

A BJP functionary explained, "We realized that retaining Manoj Tiwari as our key Purvanchali face, while replacing other candidates, would prove effective." According to state health department data, the number of patients suffering from HIV receiving treatment in Haryana hospitals has witnessed more than a hundred percent increase in the past five years, which include over 144 per cent rise among males recorded over 144 per cent as compared to females recorded as nearly 98 per

cent. Information reveals that the number of HIV patients receiving treatment in Harvana has more than doubled in the past five years. As per government record on 1st December 2024, it was stated that 15,371 HIV patients were receiving treatment under the National AIDS and STD Control Programme (NACP) in Haryana in 2019-20, which included 8,813 men, 6,525 women and 33 third-gender patients and the number increased to 16,085 in 2020-21 having 4.6

and General Secretary said that it was most shameful that Congress governments of the day did not let justice delivered to Sikh community and instead they continued to honour these guilty who were directly involved in genocide.

They said that DSGMC has played a big role in this case and has got statements of victims/ witnesses recorded in the court despite a huge pressure. The amendments aim that the legitimate commercial communication occur through registered entities, based on the preference and consent of the customers, thereby, balancing the interests of consumers with the need for supporting legitimate economic activities in the country, according to the Ministry of Telecommunications.

Consumers will now be able to make complaint against spam (UCC) calls and messages sent by unregistered senders without the need of first registering their preferences for blocking or receiving commercial communications.

"To make the complaint process simpler and more effective, it has been mandated that if a complaint made by a customer contains bare minimum essential data such as

number of the complainant, number of Sender from which the Spam/UCC has been received, date on which spam is received and a brief about the UCC Voice Call/Message, the complaint shall be treated as a valid complaint," according to revised norms.

Further, a customer can now make a complaint about spam/ UCC within 7 days of receiving spam as compared to earlier

"Time limit for taking action by the access providers against the UCC from unregistered senders has been reduced from 30 days to5 days. To ensure prompt action against the senders of UCC, the criterion for taking action against them has been revised and made more stringent," said TRAI.

As compared to earlier criterion of having 10 complaints against the sender in last 7 days' to trigger action, it has been modified to "having 5 complaints against the sender in last 10 days'.

This would enable faster action and at the same time. covering more number of spammers, according to the regulator.

The revised regulations will enable TRAI in safeguarding consumer interests while promoting a more secure and trusted digital communication

The U.S., with a fraction of India's population, produces twice the electricity. AI training and deployment are driving up energy consumption, making renewable energy integration a necessity. Commercial AI remains a high-investment, low-return field dominated by a few major players. Instead of replicating this model, India must focus on AI tailored to its unique needs. The IndiaAI Mission's initiatives, including subsidized GPU access and funding for AI projects, are steps in the right direction. Integrating AI education at scale will ensure that India retains sufficient expertise, preparing the nation to not just adapt but lead in the AI revolution.

Bridging the Global North and South



his address in January 2025, in Bhubaneswar, Odisha, while addressing the 18th Pravasi Bharatiya Divas convention, the Prime Minister, Narendra Modi, said, 'Today's India not only firmly asserts its own point but also strongly amplifies the voice of the Global South'. Similarly, when India held the 3rd Voice of Global South Summit 2024, last August, Mr. Modi said that India aspires to lead the required reforms to take developing countries into a new, more inclusive structure of global governance.

What has influenced India's renewed enthusiasm to champion the cause of the developing world? And, how can the country influence change to become an effective global development partner?

Unlike the Non-Alignment Movement (NAM), India's motivation does not appear to be based on decolonisation or strong criticism of the West. Rather, as India attempts to increase its presence in the Global South, it is simultaneously deepening its relationships with traditional partners such as the United States and Europe. The high-level visit of Jake Sullivan, the former U.S. National Security Adviser, in January, reflects this. Mr. Modi's visit to Poland, in August 2024, also shows India's attempt to create new alliances.

The China factor argument

The cynical answer often circles back to India trying to counter China's growing global dominance. Trends of foreign direct investments in Africa indicate that India appears to be in a race with China, mainly focusing on countries which already have a significant Chinese presence. Further, industrialised countries are thought to be strategically partnering with India to contain China's rising international footprint. The Quad partnership, an on-



going dialogue between Japan, India, Australia and the U.S., for a free and fair Indo-Pacific, is seen as one such attempt. However, the India-China competition does not give the full picture.

India is trying to create an individual identity as an emerging power in its own right to forward its own strategic trade, defence, and geopolitical interests. Global South countries are disillusioned with present economic paradigms, burdened with debt and conditionalities. They are not looking for another China or a new western institution. India can fill this gap while being a bridge between the Global North and Global South. To be successful, India needs to back up its rhetoric with the right strategies.

Steps that India must take

The first is for India to double-down on its call for an alternate paradigm of development cooperation that is not solely top-down, dictated by the Global North. India often lays emphasis on equal partnerships with other developing countries, powers. In practice, it signals otherwise by putting forward strategies with an India-first approach.

in the Global South, was described as rooted in Indian experiences and strategies. India's development story as an emerging power and being the world's largest democracy makes it unique. However, it does not hold all the policy answers. It would merit India to not only assert itself as a provider of knowledge but also be open to learning from other Global South countries to address its domestic challenges. Countries are bound to

be more receptive toward a country that views them as partners. Otherwise, India may also be perceived as a big brother imposing traditional donor and recipient relationships.

Second, New Delhi has laid stress on a more human-centric approach to tackle developmental challenges. This has been defined at international for atowards promoting behavioural change via Mission LiFE ('Lifestyle For Environment'), which encourages low consumption lifestyles. While important, the need is to rebrand human-centric development in order to focus on building human resource and capacity, especially to tackle future sustainability challenges. Skill India or schemes that mainstream women into entrepreneurship, will be attractive for countries in the Global South which are also seeking to grow their domestic industry. India's capacity building strategy has tended to revolve around the Indian Technical and Economic Cooperation (ITEC) programme, which implements sector-specific short-term activities. It would be more effective for longer term engagement to assist countries in creating their own institutional capacity to create a better workforce. India can leverage its experiences with micro, small and medium enterprises to foster exchanges. A focus on


digital infrastructure, climate and energy solutions as well as water and food security are key areas for cooperation.

The goal ahead

Lastly, India has called for more inclusive global governance. The nation demonstrated this intent by championing the addition of the African Union into the G-20 (in 2023) during India's presidency. India should not be content with facilitating changes in established international institutions but also learn to build domestic capacity. As India aspires to become a stronger global development player, it must establish norms, standards and systems to work with partner countries. Initially, it is beneficial to use existing institutional channels of partners such as the United Nations or Germany and France that are more experienced in development cooperation. However, the long-term goal should be for India to create its own robust domestic systems for international cooperation. Trilateral partnerships and increased engagement with new partners need to be seen as a learning by doing process, where India imbibes its experiences to scale up Indiaed global initiatives

India aspires to be the 'Voice' of the Global South, but it also must 'listen' to be a good leader. When India spearheaded NAM, the country showed the world that there is a new, third option for developing countries. India should not miss out on an opportunity to do the same thing now.

emphasises the government's commitment to inclusive development, balanced growth and prioritising the well-being of four key population groups: the poor, youth, farmers, and women. In a welcome announcement, the Finance Minister set forth a holistic vision for Viksit Bharat (or Developed India) with 'zero poverty, universal good quality school education, 100% skilled labour with meaningful employment, 70% women in economic activities, and India as the food basket of the world.' The explicit inclusion of women as a priority group within this national development framework is commendable and reinforces the government's pledge towards women-led development.

One of the most notable advancements in get to 8.8% of the total Budget, a significant jump from 6.8% in the previous year. This is the highest allocation in two decades, with 4.49 lakh crore spread across 49 Union Ministries and departments. It reflects a strong commitment to creating a more supportive and empowering environment for women and girls. Further strengthening this commitment, 12 additional central Ministries — many from non-conventional sectors such as railways, ports, shipping and waterways, land resources, pharmaceuticals, and food processing industries — have integrated gender budgets, reflecting a whole-of-government approach to gender mainstreaming.

As in the Periodic Labour Force Survey, India's female labour force participation



rate (FLFPR) measured at usual status has steadily risen, reaching approximately 42% in 2023-24 from 33% in 2021-22. This is approaching the global average of 47%, as reported by the International Labour Organisation. However, a 37-percentage point gap remains when compared to men's ce participation o ing the ambitious target of 70% women's participation in economic activities by 2047 necessitates increased investment in skilling, employment, entrepreneurship, access to productive resources, and social security entitlements — areas that the Budget has acknowledged through its various schemes. Key initiatives such as the Skill India Programme, Entrepreneurship and Skill Development Programme (ESDP), National Skill Training Institutes, Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM), the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), PM Employment Generation Programme, PM Vishwakarma, and Krishonnati Yojana have seen a combined increased allocation

from 1.19 lakh crore to 1.24 lakh crore this year. Approximately 52% of these funds are directed toward women and girls. Additionally, new schemes such as the Prime Minister Dhan-Dhaanya Krishi Yojana, first-time entrepreneurs' scheme, sustainable livelihood for urban workers initiative, and Centres of Excellence for Make in India, will play a critical role in fostering women's workforce participation.

A focus on gig workers

With 90% of India's working women engaged in the informal sector, the Budget's proposal to formalise gig workers by issuing identity cards and registering them on the e-Shram portal is a significant step. This initiative has the potential to empower millions of women by providing them with formal identity, access to social security en-I financial inclusion ben

While the gig economy has offered women financial independence and flexible work arrangements, it often comes with low wages, job insecurity, and a lack of employment rights, including maternity benefits. The enforcement of labour codes and the provision of comprehensive social security measures, including progressive parental entitlements across informal and formal sectors, will be critical to ensure women's economic security.

The establishment of a Centre of Excellence on Artificial Intelligence (AI) for the education sector and a dedicated 600 crore gender budget under the India AI Mission, demonstrate the government's intent to harness AI for social good. As technological advancements redefine the

future of work, investing in digital education, skills, and enterprise training for women will be imperative to ensuring equitable outcomes in the workforce and benefits for the entire economy.

A diversity of economic roles Financial institutions must recognise

women's diverse economic roles, particularly in agriculture, entrepreneurship, and employment. For example, simplifying documentation requirements for economic and social security provisions, such as delinking Kisan Credit Cards from land ownership, would help women farmers avail loans and credit facilities that they can use to improve crop yields, productivity and expand their agricultural and allied operations. Tracking access and usage of such schemes through gender-disaggregated data would further enhance their effectiveness.

As per the government's Udyam portal, 20.5% of the micro, small and medium enterprises are women-owned employing about 27 million people. Unlocking finance for women-owned enterprises through collateral-free loans, alternative credit scoring models, and targeted financial literacy programmes will catalyse economic growth. Bain and Company, and Google, claim that establishing 30 million additional women-owned businesses could generate 150-170 million jobs, accounting for over 25% of the job creation needed for India's working-age population by 2030.

Novel delves into the haunting realms of memory and identity

abin Iqbal's Tales from Qabristan is a deeply evocative graveyard into a metaphor for memory, history, and identity. The narrative follows Farook, the protagonist, who returns to his childhood village after his father's death. In doing so, he unearths not only personal family legacies but also suppressed histories, exposing the weight of familial and societal inheritance

At its core, Tales from Qabristan is a meditation on grief, belonging, and the shifting contours of home. Farook's journey back to his roots forces him to confront the silent tragedies embedded in his family's past. His father's failure in the Gulf, his mother's quiet suffering, and his cousin Jami's unfulfilled promise all contribute to a rich tapestry of human struggle and resilience. Iqbal weaves a non-linear narrative where time folds and unfolds, drawing together the pain of migration, the erosion of traditional values, and the deep-rooted scars of societal expectations.


One of the novel's most striking aspects is its nuanced exploration of masculinity and tradition. Farook's circumcision, a symbolic moment in his childhood, underscores the imposition of societal roles upon him. Unlike the women in his family, who are spared from such rituals, he feels trapped in an inherited identity he cannot escape. This extends to his relationship with his father, who, despite his intellectual richness, is perceived as a failure due to his inability to accumulate wealth abroad. Through this, Iqbal critiques the materialistic expectations placed upon Gulf returnees, exposing the emotional and physical toll of migration. The novel's treatment of caste

and religious identity is equally compelling. Through characters like Pankan and Kochukarumban, Tales from Qabristan highlights the struggles of marginalized communities attempting to navigate a rigid social hierarchy. Pankan, a victim of caste violence, subverts

expectations by embracing a nonconforming gender identity, becoming a living symbol of defiance. Meanwhile, Kochukarumban's attempt to escape caste discrimination through religious conversion ultimately fails, reinforcing the deeply entrenched nature of social exclusion.

Iqbal's prose is both lyrical and haunting, rich with evocative imagery that lingers in the reader's mind. His ability to capture the quiet moments of pain and resilience elevates the novel beyond a mere story of loss-it becomes a powerful commentary on memory, displacement, and the struggle for identity. The novel does not offer easy resolutions; rather, it forces readers to confront the ghosts of the past that shape the present.

The novel also engages deeply with themes of migration and economic disparity, shedding light on the experiences of Gulf returnees. Farook's father represents a group of men who leave their homeland in search of prosperity but return

empty-handed, burdened by unrealized dreams. Unlike those who amass wealth, he comes back with books and knowledge, which are undervalued in a society that equates success with financial gain. Another remarkable element in the novel is its portrayal of women and their quiet yet powerful resistance to patriarchal structures. Farook's mother, though confined by societal expectations, carries immense resilience, enduring the humiliation and judgment of relatives who criticize her husband's financial struggles. Her silent protests, whether in the

or declining financial assistance, highlight the everyday defiance that women in traditional societies practice. This adds a subtle but strong feminist undertone to the narrative. Furthermore, Tales from Qa-

form of withholding emotions

bristan presents the graveyard not just as a final resting place but as a living archive of stories, where past and present coalesce. It becomes a space where unspoken histories emerge, where forgotten voices reclaim their place, and where the weight of ancestry shapes individual identities. In this way, the novel challenges the notion of death as an end, suggesting instead that it is a continuation of memory and legacy.

Iqbal's storytelling is deeply immersive, drawing the reader into a world where time is fluid, and history is an active force shaping contemporary realities. His ability to blend social critique with deeply personal narratives makes Tales from Qabristan a standout work in contemporary Indian literature. The novel's strength lies in its ability to evoke nostalgia, pain, and an urgent need for reflection on societal changes and the lingering weight of the past.

Mark Howden, director of the search has found that the behaviour of Australia's crocodiles is changing as their body temperature increases with global warming. The research, which was published on Thursday by the

University of Queensland (UQ), analysed 15 years of data from sensors and trackers on 203 wild saltwater crocodiles in rivers on the Cape York Peninsula, Australia's northernmost point. Researchers found that the

crocodiles are spending more time at or near their critical thermal limit of 32-33 degrees Celsius, at which point their diving and swimming performance is impacted. The study found that since

2008, the temperature peaks experienced by the crocodiles have increased by 0.5 degrees Celsius and their median body temperature has increased by 0.11 degrees Celsius. Of the crocodiles that were

studied, 45 experienced body temperatures above 34 degrees Celsius at least once. As cold-blooded animals,

crocodiles cannot regulate their body temperature, relying instead on external sources. Kaitlin Barham, a co-author

of the research from UQ's School of the Environment, said that the warming environment means crocodiles are spending more time on cooling behaviours. "But if their time and energy is dominated by the need to stay cool, activity necessary for hunting, keeping safe from predators or reproducing is

Bank customers rush to buy gold amid woes over rates, Donald Trump policies

rushing to buy gold on dashed hopes for early rate cuts by the Federal Reserve (Fed) and woes over the policies of US President Donald Trump's administration, industry data showed on Wednesday.

According to the data, the country's top five banks -- KB Kookmin, Shinhan, Hana, Woori and NH Nonghyup -have sold a combined 24.2 billion won (\$16.7 million) worth of gold bars this month, sharply up from 7.96 billion won a year earlier.

The tally also marks a sharp rise from 12.4 billion won during the same period of last month, reports Yonhap news

The dim outlook for the Fed's early rate cuts, along with increased uncertainties triggered by the Trump administration's high tariffs, among other factors, is prodding bank customers to seek safe assets, such as gold.

As of Tuesday, the price of 1 gram of gold stood at 156, 230 won, the highest since March



2014, when the country's gold exchange was launched, and nearly double from 86, 000 won on Feb. 13 last year. The daily trading volume



In fact, in his writings as well as in the journals he edited, Dikshit was following Grace Morley, a well-known historian who believed in cultural democracy. Grace was one of the key figures of the San Francisco

the conservatives among the archaeologist, Sir Mortimer Wheeler, who is being ridiculed even today for his publication, Five Thousand Years of Pakistan. It is not known whether he has compromised his academic contribution to please the powers that be in Westminster or to his new employers in Pakistan. The leadership of Pakistan, which came into being only in 1947, have always been keen to claim an ancient past of their nascent state. It may also be noted that Mortimer had led the excavation of Mohenjo Daro. Earlier, he also had served as a director of the
